The Maryland Community Health System supports *House Bill 1292 – Health Insurance – Provider Panels – Credentialing for Behavioral Health Care Professionals*. This bill requires that health insurance carriers expedite the credentialing process for certain behavioral health providers, so that an application to participate in the carrier’s provider panel is decided within 60 days for those providers.

Maryland Community Health System is a network of federally qualified health centers providing primary, behavioral health, and dental services to underserved communities across Maryland. The process of credentialing providers with insurance carriers is long, inefficient, and directly impacts both our operating costs and ability to get reimbursed for services provided. In addition, there is currently a severe shortage of behavioral health providers in the state. In 2023, there were an estimated 34,613 behavioral health professionals employed in Maryland, which is only about half of the workers needed to meet the needs of Maryland’s population.¹ While we would welcome a complete overhaul of the credentialing statute, expediting the process of credentialing behavioral health care providers would be worthy start.

**HB 1351 - Health Insurance - Provider Panels - Credentialing for
Behavioral Health Care Professionals**

***** Favorable with Amendments *****

The National Association of Social Workers – Maryland Chapter (NASW-MD) strongly supports HB 1351, which aims to enhance the credentialing process for behavioral health care professionals by requiring health insurance carriers to respond to providers seeking participation in their networks within 60 days. This bill addresses an urgent need to streamline the credentialing process, which is vital for ensuring that Marylanders have access to timely and quality behavioral health care.

Currently, the prolonged delays in the credentialing process create significant barriers for social workers and other mental health professionals. In particular, social workers, who play a crucial role in the delivery of behavioral health services, are often not referred to appropriately by health insurance carriers. The lack of responsiveness and the slow pace of credentialing exacerbate the already critical workforce shortage in behavioral health care.

NASW-MD believes that this bill's provision to require carriers to accept or reject applications within 60 days will help address these workforce challenges by facilitating quicker access for social workers to join insurance networks. It will also reduce the gaps in care that many Marylanders face when seeking mental health services. Faster credentialing ensures that individuals in need of care are not left waiting and that providers can begin delivering essential services without unnecessary delays.

We request one technical amendment. On page 2, in line 10, strike “a licensed graduate social worker or” as that level of social worker no longer exists in Health Occupations §19-101.

House Bill 1351 is a step in the right direction toward addressing Maryland's workforce shortages in behavioral health care and improving access to services. We request a favorable report.
