Our state continues to grapple with persistently high rates of recidivism, a challenge that cannot be addressed without a deeper, research-driven understanding of why individuals reoffend. The incredible work of this commission is not just about expanding educational access for incarcerated individuals—it is about investigating the systemic failures that contribute to reincarceration and identifying solutions that can disrupt that cycle.


