AMENDMENT NO. 1

On page 1, in line 7, after “parties” insert “and funding”; and in line 14, after “(b)” insert “and 12-209”.

AMENDMENT NO. 2

On page 2, after line 23, insert:

“12-209.

The Mayor and City Council shall:

(1) pay from the general fund of the City that includes revenue from the Board the salaries and expenses of the Board and its employees; and

(2) devote the balance of the revenue from the Board to the general purposes of the City.”;

in line 31, after “SPECIFIES” insert “:

(1)”;

and in line 33, after “SECTION” insert “;AND

(2) IN ACCORDANCE WITH § 12-209 OF THIS ARTICLE, THE FUNDING SOURCE FOR THE UNIT”.
