Dear Chair Clippinger,

I write to you today in strong support of **House Bill 499 - the Expungement Reform Act of 2025**. As Chair of the Reentry Advisory Coalition for the City of Frederick, our coalition is committed to identifying and advocating for strategic steps that will support individuals in their journey of reintegration into society after incarceration. This bill is an essential component of those efforts.

Having personally lived the reintegration process for the past 30 years, I know firsthand the profound barriers that individuals face once they've served their time and paid their debts. Too often, the past continues to haunt them, preventing them from moving forward and becoming productive members of society. Our coalition, and our community, firmly believe that government should be a facilitator of opportunity, not a barrier to it. The ability to expand access to expungement is crucial to ensuring that those who have made a sincere effort to change are not held back by the weight of their past.

The Reentry Advisory Coalition's work emphasizes the importance of **gainful employment** in the successful reintegration of justice-impacted individuals. One of the greatest challenges that people with criminal records face in finding employment is the stigma attached to their past convictions. The opportunity to have a criminal record expunged, once the appropriate time has passed and the sentence has been fully served, is a critical step in removing that stigma. It provides a path for these individuals to show potential employers who they truly are now, not just who they were. It opens the door to second chances — to dignity, stability, and a future they deserve.

House Bill 499 recognizes that second chances should not be conditional on an arbitrary waiting period or unnecessary legal hurdles. By expanding eligibility and simplifying the expungement process, this bill will help remove one of the most persistent obstacles to employment for justice-impacted individuals: the public visibility of their criminal record. This will make a meaningful difference in the lives of many, ensuring that they are not perpetually punished for a past they've worked to leave behind.
