## Support for House Bill 648 – Economic Development – Business Resource Initiative for Developmental Growth and Empowerment (BRIDGE) Program – Establishment

## Dear Chair Atterbeary and Esteemed Committee Members,

At Maryland Latinos Unidos (MLU), we recognize that small businesses are the backbone of our communities. For Maryland's Latino entrepreneurs, however, access to the capital, resources, and mentorship necessary to build and sustain successful businesses remains a significant challenge.
