Dear Chairman Barnes, Chairwoman Atterbeary, and Committee Members

I am writing on behalf of the Cloverleaf Standardbred Owners Association, representing approximately 450 Maryland horsewomen and men involved in the standardbred racing industry, including breeders, owners, trainers, drivers, grooms, and other industry participants.

We have serious concerns about the proposed reduction of the Purse Dedication Account (PDA) from 6% to 5%. This seemingly minor 1% reduction would have significant cascading effects on the Maryland Standardbred Breeders Fund, resulting in a 16% decrease in funding. This fund is crucial for supporting horses sired or foaled in Maryland, and any cuts would disproportionately impact the small-scale breeding operations that make up roughly 50% of Maryland's breeders. Additionally, Winbak Farms of Cecil County, MD, the largest Standardbred breeder in North America, would be adversely affected. In 2024 alone, Winbak bred horses earned over \$20 million and won over 900 races worldwide, demonstrating their significant contribution to the industry.

Furthermore, the proposed PDA reduction would lead to over a 16% decrease in overnight purse accounts for Ocean Downs and Rosecroft Raceway. These accounts primarily benefit Maryland residents and those with Maryland connections, as over 80% of the overnight purse account is paid to them. Of the 12,000 horses racing annually in Maryland, approximately 9,700 are Maryland Owned, Sired, and Bred, highlighting the importance of these accounts for the local industry.

The Maryland Standardbred racing industry has already faced substantial purse fund reductions due to the introduction of various alternative gambling options within the state. The current 6% direct contribution to the Purse Dedication Account has been essential in maintaining the industry's viability, despite operating on a very narrow profit margin. A further 16.67% reduction in the Purse Dedication Account would undoubtedly deliver a devastating blow to an industry deeply rooted in Maryland's history, spanning over 250 years.



Dear Honorable Appropriations Committee Members:

I am writing to express my strong opposition to the proposed reduction of the VLT percentage to the Purse Dedication Account from 6% to 5%. This reduction would have significant negative consequences for horse racing, Maryland's economy, tourism, agriculture and open space.

The funding allocated to the Purse Dedication Account supports critical initiatives that reinforce and contribute to the infrastructure of Maryland Racing. A reduction of even 1% would undermine the industry's stability and impact all of the progress, programs, and services derived from racing operations.
