
Medical errors and preventable harm in U.S. healthcare remains a major public health challenge, resulting in hundreds of thousands of deaths and serious injury annually. Marylanders face similar concerns.

MPSC serves as the state's independent improvement arm for patient safety—supporting hospitals, clinicians, and partners to reduce preventable harm, improve maternal and patient outcomes, and advance health equity. Rather than depending on every health care organization to discover and reinvent solutions, MPSC drives and accelerates the standardization and adoption of best practices across the state. This work directly benefits all Marylanders, including those with Medicaid coverage and the state's most vulnerable populations. The return on this investment is clear: fewer preventable complications, lower costs to the Medicaid program, and better outcomes for all Marylanders.

The General Assembly previously recognized this as a public good and created dedicated state funding for this role. Restoring this \$1M investment preserves critical statewide infrastructure at an exceedingly small fraction of Maryland's total healthcare spend. Without this restoration, Maryland is at real risk of losing its patient safety center, which serves a purpose like a National Transportation Safety Board for healthcare.

Thank you for your leadership and for your commitment to patient safety. **I urge you and your Senate colleagues to fully support SB0587, which includes \$1 million for patient safety in the annual state budget.**

On behalf of the Maryland Hospital Association's (MHA) member hospitals and health systems, we appreciate the opportunity to comment in support of Senate Bill 587.

The Mid-Atlantic Patient Safety Center (MPSC), formerly the Maryland Patient Safety Center, which formed in the early 2000s, was one of the first 25 organizations in the country to be recognized as a Patient Safety Organization by the Agency for Healthcare Research and Quality.¹ MPSC engages in statewide collaboratives and initiatives to prevent avoidable harm and provide safe and equitable health care for all.

Despite having a staff of less than five people, MPSC has a broad, statewide impact. In 2025, MPSC offered more than 75 educational programs across the country, trained more than 4,000 health care workers and held two conferences on medical safety and patient safety attended by more than 350 and 600 people, respectively.²

During the COVID-19 pandemic, they engaged in the Clean Collaborative, a partnership with Maryland's nursing homes, to improve infection control through rigorous environmental cleaning to prevent transmission of infectious diseases, such as Clostridium difficile (C. difficile), Methicillin Resistant Staphylococcus Aureus (MRSA), and COVID-19. All these infections can result in unnecessary visits to the emergency department and other, more serious, outcomes. Participating facilities decreased C. difficile rates by 14.2%, compared to a 5.9% decrease among non-participating facilities.³

MPSC set out to improve outcomes for neonatal abstinence syndrome (NAS) by working with birthing hospitals to put in place best practices for care of infants with NAS. Through this work, MPSC helped reduce length of stay by 1.5 days and achieved a 50% decrease in the rate of interhospital transfers. The results of their work have been published in the American Journal of Perinatology.⁴

MPSC has also supported hospitals' efforts to improve maternal morbidity. MPSC engaged renowned experts on the Maternal Health Equity Project, an initiative to educate non-obstetric providers, such as emergency department physicians, on racial bias, maternal morbidity and the importance of the patient's voice and experience.

MPSC also led the launch of a public awareness campaign, *Care Flows Both Ways*, in 2025 to educate the public on the impact of workplace violence on the health care workforce. The campaign, created through a work group established by state legislation, features real Maryland hospital workers sharing their stories.⁵

State funding ensures access and accountability as Maryland continues to serve as a national leader and trailblazer. Requiring rather than authorizing funding will help guarantee MPSC can continue to do important things like the aforementioned projects and continue to serve as a convener for health care facilities across the state.

For these reasons, we request a favorable report on SB 587.

- Developing, coordinating, and implementing patient safety initiatives statewide

- Serving as a model for patient safety innovation
- Convening health care providers, patients, and families to reduce avoidable harm
- Sharing best practices across Maryland's health care system

The bill ensures consistent funding, which is essential for sustaining statewide safety improvements.

The Maryland Patient Safety Center plays an irreplaceable role in safeguarding patients and advancing statewide health care quality. Restore \$1M Funding to the State’s Designated Patient Safety Center

A State Responsibility & Designation

In statute, the State of Maryland, through the Maryland Health Care Commission, designates a Patient Safety Center to lead systemwide improvement in healthcare safety. That designated center is the Maryland Patient Safety Center (MPSC). With this designation comes a public responsibility—and a clear rationale for sustained state investment. Although MPSC is an independent nonprofit, it is the state’s official convener for learning, improvement, and harm prevention across Maryland healthcare.

Safe care does not happen by accident: we help prevent harm before it happens. From reducing preventable infections to improving care during childbirth, our work helps prevent avoidable harm. It’s hard to measure what doesn’t happen—but the saving in lives, health and cost are real.

Why the State Must Fund This Work

Hospitals play a critical role in improving care, but statewide safety infrastructure exists to serve the public good. Relying solely on hospitals to fund a statewide safety center is akin to expecting airlines alone to fund the FAA or NTSB. Patient safety is a shared public interest: Marylanders expect safe care regardless of geography or care setting, and ensuring that consistency is a state-level obligation.

When safety infrastructure is funded only by hospitals, smaller or rural institutions—and non-hospital settings such as urgent care, assisted living, and nursing homes—risk being left behind. State funding ensures equity, access, and accountability. Moreover, the benefits of improved safety—reduced Medicaid spending, better outcomes, and workforce retention—accrue to the state as a whole, not just individual hospitals.

How the State Gets Value from Its Investment

- ✓ **Return on Investment:** MPSC reduces avoidable harm, lowering Medicaid and system-wide costs by decreasing complications, hospitalizations, lengths of stay, readmissions, emergency department use, and post-acute care. These savings extend across Medicaid, state employee health plans, and uncompensated care.
- ✓ **Trust and Confidence in Maryland Healthcare:** MPSC strengthens public trust through prevention, reinforcing the infrastructure that supports safe, high-quality care statewide—before crises occur.
- ✓ **Equity and Statewide Reach:** MPSC serves all Maryland hospitals, ensuring consistent safety standards across large systems and smaller, rural institutions alike.

A Proven Model: Like the NTSB, But for Healthcare

The National Transportation Safety Board (NTSB) investigates accidents to improve transportation systems through protected, non-punitive learning.

MPSC serves a comparable role in healthcare. As a federally listed Patient Safety Organization, MPSC provides legally protected environments for healthcare organizations to learn from adverse events and near misses—improving systems without blame or litigation. This trusted convening function is essential state infrastructure.

NTSB’s recommendations prevent future accidents, saving lives and taxpayer dollars. MPSC’s programs (on falls, maternal morbidity, medication safety, etc.) reduce costly preventable harm—generating **return on investment** across Medicaid, state employee health plans, and uncompensated care.

State funding for MPSC yields cost savings far greater than the appropriation. Just like NTSB reports, MPSC findings translate to **systemic efficiencies** and long-term public benefit.

Our Ask

Restore and sustain **\$1 million in annual state funding** for the nonprofit Maryland Patient Safety Center, the state’s designated patient safety center. This investment ensures equitable access to safety infrastructure, protects healthcare workers, reduces Medicaid and state employee health plan costs, and keeps Marylanders safe—demonstrating a proactive, bipartisan commitment to public well-being.



Dear Members of the Maryland General Assembly:

As leaders of quality and patient safety across Maryland’s health systems, we urge you to restore **\$1 million in the FY27 state budget for the Maryland Patient Safety Center (MPSC).**

Every day, hospitals work tirelessly to prevent harm, but some risks cannot be solved by any one institution. Recently, portable oxygen tanks were depleting during patient transport—a deadly situation. Because of MPSC, that lesson was rapidly shared statewide, and hospitals collectively identified and shared improvements, and engaged manufacturers to address the problem. Without this infrastructure, the same failure could have harmed patients again and again in different Maryland hospitals.

MPSC functions like an “NTSB” for healthcare. Just as the federal government funds the NTSB to identify patterns across airlines and railroads, Maryland needs MPSC to detect and prevent repeat events across hospitals, nursing homes, and urgent care centers. This work saves lives and avoids costs—each prevented adverse event (such as an infection, readmission, or surgical complication) can save \$20,000–\$50,000 or more. Preventing even a handful of these incidents annually offsets the entire state investment.

Maryland already funds prevention in other areas of public life—fire safety, car theft, highway patrol—because the public deserves protection from predictable harms. Patient safety is no different. It is a shared public good that requires a modest, reliable state investment to ensure every Marylander benefits, no matter where they receive care.

For the State, patient safety is not only a moral obligation but a fiscal imperative. Preventable harm drives higher Medicaid costs, increases state employee health plan expenditures, and reduces workforce productivity. By preventing adverse events, MPSC reduces avoidable state spending and strengthens Maryland’s healthcare system for all.

The requested \$1 million is small compared to the cost of preventable harm, but its impact is profound: fewer tragedies, faster learning, and measurable taxpayer savings. It is both the right thing to do for Maryland families and the smart thing to do for Maryland’s budget.

We respectfully urge your support for restoring and maintaining this critical funding in FY27.

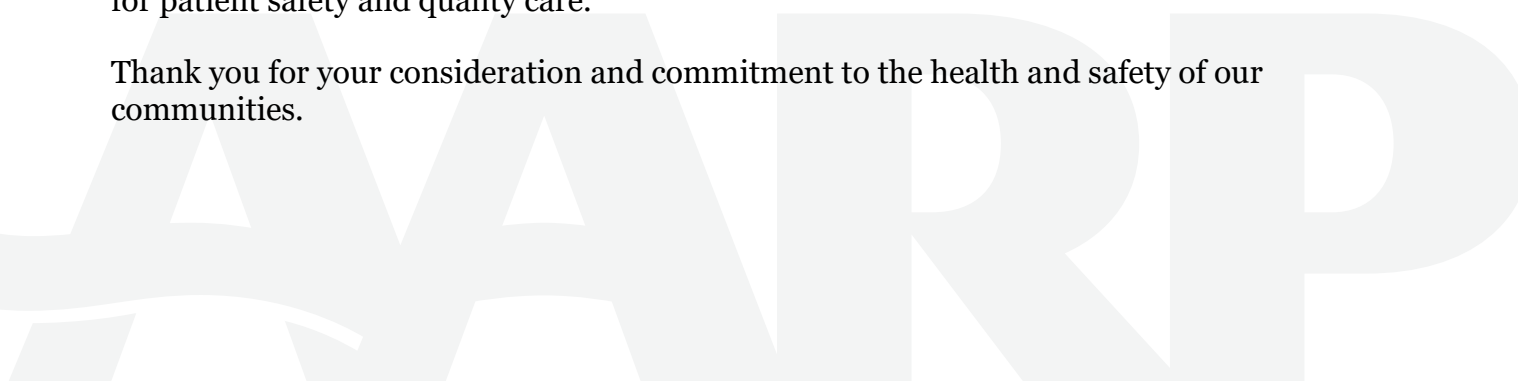



SUMMARY OF BILL: This legislation reinstates the mandates that the Governor include an appropriation of \$1 million for the Maryland Patient Safety Center Fund in FY27 and each year thereafter. The Maryland Patient Safety Center is responsible for developing, coordinating, and implementing patient safety initiatives across the State.

EXPLANATION: This legislation would require an appropriation of \$1 million. General fund expenditures would increase annually. Previously, there was a funding mandate for FY 2023 to 2025; however, the Budget Reconciliation and Financing Act of 2025 eliminated it, effective in fiscal year 2026. If passed, this will increase general fund expenditures in the State by \$1 million annually beginning in fiscal year 2028.

Given the significant uncertainty in federal policy and the escalating fiscal shortfalls forecasted through Fiscal Year 2028, the Department urges caution against legislation that increases expenditures or diverts revenue without sustainable funding offsets. In light of the current fiscal crisis, the State must remain disciplined and strategic in its funding decisions to protect essential services for all Marylanders.

Dear Chair Guzzone and Committee Members,

The Maryland Health Care Commission (MHCC) respectfully submits this letter of information on *SB 587 - Maryland Patient Safety Center Fund - Funding House Bill*. SB 587 requires, rather than authorizes, the Governor to include an appropriation of \$1,000,000 to the Maryland Patient Safety Center Fund in the annual budget bill for fiscal year 2027 and each fiscal year thereafter.

In 2001, the Maryland General Assembly enacted the Patient Safety Improvement Act, directing the Maryland Health Care Commission (MHCC) to study the feasibility of developing a system to reduce preventable adverse medical events in Maryland, including a reporting framework for such incidents. Following this study, MHCC recommended the creation of the Maryland Patient Safety Center (MPSC) to advance patient safety statewide.

In 2003, the General Assembly formalized this initiative by granting medical review committee status to the entity designated by MHCC as the Maryland Patient Safety Center. As a result, the proceedings, records, and files of the designated Center are confidential and are not discoverable or admissible in civil actions pursuant to Md. Code Ann., Health Occ. § 1-401(d)(1). In 2004, MHCC officially designated MPSC to implement a coordinated, statewide strategy to improve healthcare quality and reduce medical errors.

At the federal level, in 2005, United States Congress passed the Patient Safety and Quality Improvement Act, authorizing the creation of Patient Safety Organizations (PSOs) to enhance healthcare quality and safety by reducing events that adversely affect patients. To implement this law, the Agency for Healthcare Research and Quality (AHRQ) issued the Patient Safety and Quality Improvement Final Rule (42 C.F.R. Part 3). The Mid-Atlantic Patient Safety Organization (Mid-Atlantic), a component of MPSC, has been recognized by AHRQ as a federally listed PSO.

Over the past two decades, MHCC has played an essential oversight role in monitoring MPSC’s compliance with its designation requirements. The Commission also facilitates collaboration among the Center, state agencies, and other stakeholders to ensure alignment with Maryland’s healthcare priorities, including the Total Cost of Care Model and the AHEAD Model.

Historically, a significant portion of MPSC’s funding was provided through Maryland’s hospital rate-setting system as seed funding. During the 2022 legislative session, Senate Bill 591 established a special, non-lapsing fund to support MPSC in the amount of \$1 million annually. This fund was administered by MHCC until the funding concluded in FY 2025.

MHCC continues to evaluate the performance of the Patient Safety Center in accordance with the standards and requirements set forth in the current Designation Agreement. At its March 20, 2025 public meeting, the Commission voted to extend the MPSC Designation Agreement through June 30, 2027.
