Subject: Request for **FAVORABLE Report** – SB0238 – School Psychologist Interstate Licensure Compact

Dear Chair Feldman and distinguished members of the Education, Energy, and the Environment Committee:

On behalf of the members of the Maryland Military Coalition<sup>1</sup> (MMC), I write to request a **FAVORABLE report** by the Committee on **SB0238 – School Psychologist Interstate Licensure Compact** sponsored by Senator Malcolm Augustine. This bill would enter Maryland into the School Psychologist Interstate Licensure Compact that was developed by the Council of State Governments (CSG) in partnership with the Department of Defense (DoD) and the National Association of School Psychologists (NASP) to support the mobility of licensed school psychologists.

School psychologists provide critical services for children across the country to better support learning, mental health, and behavior in schools. There is, however, a shortage of school psychologists in Maryland. According to data from NASP, as of February 2026, Maryland's current ratio is 1,037:1<sup>2</sup> compared to the recommended ratio of 500-750:1. This shortage not only harms students, but also further stretches thin the ability for teachers and administrators to focus directly on their roles. The Interstate Compact for School Psychologists (ICSP) provides an additional tool in the toolbox for Maryland in addressing shortages in our state. In addition, the ICSP maintains Maryland's sovereignty and does not alter the State's ability to regulate the school psychologist profession or licensure.

By passing SB0238, Maryland can join seven other states that have enacted this compact. This compact will benefit practitioners who are spouses of members of the armed forces by:

- Facilitating multistate practice
- Enhancing license portability when official orders require a change of duty stations
- **Support relocating military spouses, a key goal of the MMC**
