We write to express our strong support for SB 665, sponsored by Senator Harris, regarding the renaming of the Governor’s Office of the Deaf and Hard of Hearing and the Maryland Advisory Council on Deaf and Hard of Hearing.

SB 665 renames the Governor’s Office of the Deaf and Hard of Hearing and the Maryland Advisory Council on Deaf and Hard of Hearing to explicitly include DeafBlind individuals. While the bill’s changes may appear technical, their impact is substantial and long overdue. By formally recognizing the DeafBlind community in statute, the State of Maryland affirms its commitment to full inclusion, equity, and accurate representation of the communities these entities are charged with serving.

DeafBlind individuals face unique and complex barriers related to communication access, mobility, employment, healthcare, emergency preparedness, and civic participation. Their experiences and needs are distinct from, though connected to, those of Deaf and Hard of Hearing individuals. Explicit inclusion in the names of the Office and Advisory Council ensures that DeafBlind Marylanders are not overlooked in policy development, service planning, and state decision-making processes. Names matter. Statutory recognition matters. When communities are explicitly named, government accountability and visibility follow.
