### ARTICLE IV: PLUMBING CODE

#### § 1-14-56. ADOPTION.

There is hereby adopted by the County those certain plumbing regulations known as the [2015] 2018 Edition of the International Plumbing Code, and the whole thereof; and the same is hereby adopted, ratified and incorporated as fully as if set out at length herein subject to the local amendments described below in § 1-14-57.

#### § 1-14-57. AMENDMENTS.

The International Plumbing Code is hereby amended and changed as described and shown below.

[*Subsection 417.4.1* is hereby amended to add the following text:

No windows shall be in the 70-inch wall area. Waterproofing materials of epoxy or paint coatings are prohibited.]
