#### Performance Measures and Outputs

As shown in **Exhibit 1**, enrollment at the Maryland School for the Deaf (MSD) increased on a year-over-year basis from fiscal 2013 through 2017. However, the school estimates declining enrollment in both fiscal 2018 and 2019. At the Frederick campus, the location of future State programmed capital funding to replace existing residence halls, residential enrollment declined from fiscal 2013 to 2017 as daytime student enrollment increased. As a percentage of total enrollment, residential enrollment declined from 47% in fiscal 2013 to 29% in fiscal 2017. **The department should explain how estimated enrollment is calculated and why the fiscal 2019 estimate projects decreasing enrollment.**

#### **Budget Overview**

#### **Veditz Building Renovation – Frederick Campus**

The fiscal 2019 capital budget provides \$586,000 to begin the design of renovations of the Veditz Building. This project will renovate both floors of the building to better match the needs of the school's career technology curriculum. Currently, the layout has large open spaces for classrooms suited for the old vocational curriculum, including wood shop and home economics courses. The redesign will allow for an increased number of classrooms to accommodate the campus' increasing enrollment and smaller classrooms to provide better wiring capabilities for computer laboratories. Between fiscal 2016 and 2017, enrollment at the Frederick campus increased by 26 students, or 7.1%.

#### RE01 - Maryland School for the Deaf

The estimated cost of this project totals \$9.84 million, \$8.15 million more than previous estimates. This substantial increase in cost is attributable to the project expanding from renovating one floor to both floors. The renovation will include infrastructure upgrades to the mechanical, electrical, and plumbing systems.

In addition to the building renovation project, there is a roof replacement project planned for the Veditz Building in fiscal 2019. Roof maintenance is funded by the Department of General Services Statewide Facility Renewal Program. According to MSD staff, the projects will not conflict with each other.

The Veditz Building will be vacated during the construction phase, and the operating impact statement includes the cost of renting relocatable classrooms so educational programming can continue during construction.

### Summary of Other Projects in the Capital Improvement Program

#### High School Boys' and Girls' and Middle School Residences - Frederick Campus

Funds are included in the five-year *Capital Improvement Program* to construct a new high school boys' residence and student center, a high school girls' residence and satellite health center, and the middle school residence and central offices. New residences are required to address the Americans with Disabilities Act and fire code deficiencies, allow for proper student supervision, and provide a more home-like environment for students. In fiscal 2017, there were 89 residential students, or 22.8% of students at the Frederick campus. The estimated cost of the project totals \$22.9 million. Initial design is programmed for fiscal 2021, and the anticipated completion date is April 1, 2027.
