
Maryland Commission on African American History and Culture

Program Description

Chapters 451 and 452 of 2022 established the Maryland Commission on African American History and Culture (MCAAHC) as an independent unit within the Executive Branch. Previously, the commission's budget was included in the D15A05 – Executive Department – Boards, Commissions, and Offices analysis. MCAAHC aims to educate both Maryland citizens and visitors about the importance of African American heritage in the State. This involves discovering, documenting, preserving, and endorsing Maryland's African American heritage along with providing technical support to African American museums, universities, and heritage sites. The commission seeks to enhance the accessibility of African American heritage preservation in Maryland for current and future generations. Additionally, MCAAHC oversees the operation of the Banneker-Douglass Museum, Maryland's official State museum on African American history and culture.

Operating Budget Summary

Fiscal 2025 Budget Increases \$22,262, or 1.4%, to \$1.6 Million (\$ in Thousands)

• Chapters 451 and 452 require that the Governor include \$1,600,000 for the commission in the annual budget bill. As a result, MCAAHC's budget increased from \$834,448 in fiscal 2023 to \$1.6 million in the fiscal 2024 working appropriation and fiscal 2025 allowance.


African American Heritage Preservation Program Grants

MCAAHC administers the African American Heritage Preservation Program (AAHPP) with the Maryland Historical Trust (MHT). The goal of the program is to identify and preserve buildings, communities, and sites of historical and cultural importance to the African American experience in Maryland. This competitive grant program supporting African American heritage properties is offered yearly to nonprofit organizations and local jurisdictions. In April 2023, Governor Wes Moore announced that the fund for the AAHPP would increase from \$1 million to \$5 million. On January 19, 2024, Governor Moore announced that the commission, with MHT, had awarded 24 AAHPP grants totaling \$5 million in fiscal 2024, ranging from \$63,500 to \$250,000, to Maryland nonprofit organizations and one State agency. Funding for this program is included in the capital budget appropriation for the Department of Planning.

Fiscal 2025 Overview of Agency Spending

The fiscal 2025 allowance provides a total of \$1.6 million for MCAAHC. **Exhibit 1** illustrates how these funds are allocated by function. The largest share of the allowance supports personnel, totaling approximately \$1.4 million (or 83%), and includes 11 regular positions. The remaining funding reflects the Banneker-Douglass Museum's operational expenses, which are overseen by MCAAHC.

Proposed Budget Change

As shown in **Exhibit 2**, the fiscal 2025 allowance increases by \$22,262, or 1.4%, compared to the fiscal 2024 working appropriation. The largest change in the fiscal 2025 allowance is driven by the net change in personnel due to the conversion of 2 contractual full-time equivalent positions to regular positions, amounting to \$29,747.


- The fiscal 2025 allowance includes two contractual conversions: one research and preservation specialist position, which drafts and coordinates AAHPP grant agreements, processes payments, and provides technical preservation information to the public and to local and State agencies; and an agency grant specialist position that provides support to AAHPP grantees and assists in writing and researching grants.
- The budgeted turnover rate in the fiscal 2025 allowance is 5.75%, a 5.75 percentage point increase over the 0% rate included in the fiscal 2024 working appropriation. This elevated budgeted turnover better aligns with the 4 vacancies as of December 31, 2023, though MCAAHC still had 3.48 more vacancies than needed to meet this budgeted turnover.

Key Observations

1. Banneker-Douglass Museum Engagement Declines

MCAAHC oversees the operation of the Banneker-Douglass Museum, which is Maryland's official State museum on African American history and culture. **Exhibit 3** shows visitors' engagement with the Banneker-Douglass Museum from fiscal 2019 to 2023. The COVID-19 pandemic altered the way MCAAHC measures accessibility and visibility to interested audiences. During the pandemic-related limitations on in-person visitation, the museum shifted to a larger online presence and began including online interactions in its reported visitor measure beginning in fiscal 2020. Starting in fiscal 2022, engagement data is reported as in-person visitations along with engagement via various online platforms, including the MCAAHC and museum websites and social media. Although overall engagement from fiscal 2022 to 2023 decreased by 5%, in-person visitors totaled 7,392 individuals in fiscal 2023, or 52% more than the in-person visitors to the museum in fiscal 2022.

Exhibit 3 Banneker-Douglass Museum Engagement Fiscal 2019-2023



The new engagement metrics that MCAAHC began reporting with the fiscal 2022 actual data include tracking visits to the MCAAHC and Banneker-Douglass Museum websites as well as social media engagement with profiles for the museum on Facebook, Instagram, and LinkedIn, and YouTube. By providing information and access in a virtual environment, MCAAHC is able to increase awareness of the commission's work and the Banneker-Douglass Museum. In fiscal 2023, 142,692 interactions were recorded with the MCAAHC and Banneker-Douglass Museum websites, YouTube channel, and other social media profiles. 

(in Thousands)



Exhibit 5 shows the number of festivals, meetings, and similar events that the commissioners attended in each fiscal year. Although the events attended have more than doubled from 134 in fiscal 2022 to 276 in fiscal 2023, this measure has yet to return to the prepandemic level of 465 events attended in fiscal 2020.
