Notice of Proposed Action

The Secretary of Natural Resources proposes to amend Regulation .11 under COMAR 08.03.09 Wildlife Possession.

Statement of Purpose

The purpose of this action is to amend the regulation to provide for training sessions on the safe and appropriate use of rifles for the purpose of deer control. The proposed amendment satisfies a requirement of legislation enacted during the 2014 session of the Maryland General Assembly.

There is no corresponding federal standard to this proposed action.

C. Qualifications for a Deer Cooperator Permit.

(4) Except as provided in §C(5) of this regulation, an individual applying for a deer cooperator permit is required to successfully complete a shooting proficiency test administered by the Service, or provide proof of successful completion of an approved comparable shooting proficiency test.

(a) The Service shall offer training sessions on the safe and appropriate use of rifles for the purpose of controlling the deer population.

(b) The Service will schedule this training as needed with priority given to persons holding a deer management permit in accordance with COMAR 08.03.04.02.
