The Secretary of Health and Mental Hygiene proposes to amend:

- 1) Regulations .06, .07, and .08 under COMAR 10.22.17 Fee Payment System for Licensed Residential and Day Programs; and
- 2) Regulation .04 under COMAR 10.22.18 Community Supported Living Arrangements Payment System.

Statement of Purpose

The purpose of this action is to enact in regulation FY16 reimbursement rates.

A. A 3.00 percent increase in rates will cause the expenditures of the Developmental Disabilities Administration (DDA) for community services to increase by an estimated \$28,146,327 in total funds (\$15,690,675 in general funds). In addition, an increase to the rates for supported employment providers to create parity with day service providers will cause the expenditures of the DDA to increase by an additional \$251,597 in total funds (\$143,062 in general funds). The total general funds impact of these changes is \$15,833,737.

D. Regulated provider agencies will benefit from increases to rates by an estimated \$28,397,924 in total funds (\$15,833,737 in general funds).
