The State Board of Elections proposes to amend Regulation .01 under COMAR 33.01.01 Definitions.

This action was considered by the State Board of Elections at its September 24, 2015 meeting, notice of which was given in accordance with State Government Article, §10-506(c), Annotated Code of Maryland.

Statement of Purpose

The purpose of this action is to reflect the current practice of SBE personnel processing voter registration and absentee transactions for military and overseas voters. This is required because SBE received a grant from the U.S. Department of Defense's Federal Voting Assistance Program to create central processing of election-related transactions for military and overseas voters.

The citation in the authority line is amended since the location in the U.S. Code of the Uniformed and Overseas Civilians Absentee Voting Act has been transferred from Title 42 to a new title, Title 52.

There is no corresponding federal standard to this proposed action.
