### **Comptroller of the Treasury**

Proposed Regulation DLS Control No. 19-147 Comptroller of the Treasury: Online Fantasy Competitions: General Provisions: COMAR 03.11.01.

According to the office, the purpose of this action is to repeal in their entirety existing regulations 03.11.01 (Fantasy Sports Competition Regulations) under Title 03 (Comptroller of the Treasury).

### **Planning**, **Department** of

Proposed Regulations DLS Control No. 19-148 Department of Planning: Historical and Cultural Programs: Heritage Structure Rehabilitation Tax Credit Certifications: COMAR 34.04.07.01 through .06 and .08

According to the department, as necessary to (1) implement statutory changes made during the 2019 Session and (2) bring the regulations into conformance with current agency practices or to support better management of the Program. As required by Chapter 211 of the 2019 Laws of Maryland, these amendments:

- change the name of the program from the Heritage Structure Rehabilitation Tax Credit to the Historic Revitalization Tax Credit.
- add an additional 5% credit and 7.5% credit for a Small Commercial and Competitive Commercial project that results in, respectively, a level 1 opportunity zone project or a level 2 opportunity zone project.
- change the qualification standards for the Small Commercial Tax Credit by:
  - eliminating the requirement that a project result in a structure that is not more than 75% rental residential;
  - adding rehabilitations of residential units located within a series of similar residential units that are undertaken by a developer and then sold for residential purposes;

• adding rehabilitations of agricultural structures and post-World War II structures as defined. The amendments also add a definition for "agricultural structure" that is consistent with how the Maryland Department of Agriculture generally defines the term.

### Criminal Sentencing Policy, Commission on

Proposed Regulations DLS Control No. 19-138 Independent Agencies: Commission on Criminal Sentencing Policy: General Regulations: COMAR 14.22.01.03, .10, and .12

According to the commission, the purpose of this action is to indicate modifications to the computation of the offender score in Regulations .03, .10, and .12 under COMAR 14.22.01 General Regulations. These modifications clarify the instructions for scoring Part A of the offender score (i.e., relationship to the criminal justice system when the instant offense occurred) when a sentencing event involves two or more criminal offenses, and the defendant was under criminal justice system supervision when one offense occurred but not under criminal justice system supervision when the other offenses based on the defendant's relationship to the criminal justice system at the time of each offense, rather than requiring that Part A of the offender score be the same for each offense in the sentencing event.

Proposed Regulations DLS Control No. 19-150 Independent Agencies: Maryland Health Benefit Exchange: Eligibility Standards for Enrollment in a Qualified Health Plan and a Qualified Health Plan with APTC and CSR in the Individual Exchange: COMAR 14.35.07.12, .13, .18, and .19

According to the exchange, the purpose of this action is to amend existing regulations for conformity with federal requirements.

Maryland Department of Health

Proposed Regulation DLS Control No. 19-136 Maryland Department of Health: Medical Care Programs: Family Planning Program Eligibility: COMAR 10.09.37.02 through .13

According to the department, the regulations clarify and update eligibility rules for the Maryland Medicaid Family Planning Program in order to integrate the program into the Maryland Health Connection and as required by the Centers for Medicare and Medicaid Services.

According to the department, the purpose of this action is to:

- authorize the Maryland Medical Cannabis Commission (MMCC) to award up to 22 medical cannabis grower licenses;
- authorize the MMCC to award up to 28 medical cannabis processor licenses;
- establish an initial licensing period of up to 6 years for medical cannabis growers, processors, and dispensaries;
- require the MMCC to establish enforcement procedures for newly codified advertising restrictions; and
- establish a registration process for academic research institutions to obtain medical cannabis for bona fide research projects.

According to the department, the purpose of this action is to establish the fiscal year 20 reimbursement rates for Licensed Residential and Day Programs and Personal Support services as part of Community Supported Living Arrangements (CSLA) services in accordance with Health – General Article, §7-307(d), Annotated Code of Maryland.

According to the department, the purpose of this action is to add State licensed forensic laboratories as permitted employers of certified analysts in an effort to allow these analysts to provide testing services for State law enforcement agencies.
