Transfer of Human Remains and Associated Funerary Objects: COMAR 34.04.06.01 -.10

According to the department, the purpose of this action is to revise and update the regulations governing transfer by the Maryland Historical Trust ("MHT") of human remains and associated funerary objects in MHT's possession, custody, and control. This action will: (1) correct inconsistencies between the regulations and statute; (2) reconstitute the Burial Sites and Object Review Committee as an ad hoc committee instead of a standing committee; (3) ensure that prior notice is given to the relevant State ethnic commissions when a transfer of ethnic remains or objects is contemplated; (4) adjust review procedures to make them more practical and workable; (5) reorganize certain provisions and add clarity and uniformity; and (6) remove unnecessary and inapplicable text.

According to the department, the purpose of this action is to reduce the number of days from 180 to 120 for a horse to enter a claiming race without being subject to being claimed.

Utility Service Protection Program: COMAR 20.31.05.01, .05, .07, .08, and .09

According to the commission, the purpose of this action is to (1) eliminate the requirement of a waiver of COMAR 20.31.05.08C(3), which limits the application of Maryland Energy Assistance Program ("MEAP") funds for customers participating in the Commission's Universal Service Protection Program ("USPP"), to first time participants in the USPP, absent a waiver; (2) permit first-time USPP applicants to choose to apply all or part of their MEAP benefit to arrearages in order to qualify for USPP, but this is a one-time election; (3) enable USPP participants to apply the MEAP grant to arrearages for USPP participation and eliminate the first time applicant limitation; and (4) eliminate the administrative process of utilities requesting waivers of COMAR to enable them to use the MEAP Grant funds to pay down customers' arrearages in order to participate in USPP.
