HOUSE BILL INTRODUCED FEBRUARY 27, 2014

HB 1512 Delegates McDermott and Conway

WORCESTER COUNTY – ALCOHOLIC BEVERAGES LICENSES

Authorizing the Worcester County Board of License Commissioners to issue a specified alcoholic beverages license within the corporate limits of the Town of Berlin, the corporate limits of the Town of Snow Hill, or the corporate limits of the City of Pocomoke.

HOUSE BILLS INTRODUCED FEBRUARY 28, 2014**HB 1513 Harford County Delegation**

HARFORD COUNTY REPUBLICAN CENTRAL COMMITTEE –
MEMBERSHIP

Altering the membership of the Harford County Republican Party Central Committee; providing that specified Republican Party members of the House of Delegates who represent Harford County shall be members of the Central Committee; providing that the Republican Party members of the House of Delegates on the Central Committee may vote on matters, as specified; prohibiting a member of the Central Committee from holding any other elected office in the county; making the Act an emergency measure; etc.

CREATION OF A STATE DEBT – ANNE ARUNDEL COUNTY –
CAPTAIN AVERY MUSEUM WINDOW REPAIR AND RESTORATION

Authorizing the creation of a State Debt not to exceed \$38,000, the proceeds to be used as a grant to the Board of Directors of the Captain Avery Museum, Inc. for specified development or improvement purposes related to the Captain Avery Museum, including repair and restoration of the windows, located in Anne Arundel County; providing for disbursement of the loan proceeds, subject to a requirement that the grantee provide and expend a matching fund; establishing a deadline for the encumbrance or expenditure of the loan proceeds; etc.

SALES AND USE TAX – DEFINITION OF TAXABLE PRICE

Defining “taxable price” for specified tangible personal property, for purposes of provisions of law concerning the sales and use tax, to mean all consideration paid by a transient guest to the vendor for the right to occupy a room or lodgings; etc.

HB 1516 Delegates Hixson and Frick**ECONOMIC DEVELOPMENT – ARTS AND ENTERTAINMENT DISTRICTS – QUALIFYING RESIDING ARTISTS**

Altering the definition of qualifying residing artist for an arts and entertainment district to include individuals who own or rent residential real property in the State and who conduct business and derive income in specified areas; altering the eligibility for specified individuals to claim specified tax incentives; etc.

HB 1517 Delegates Glenn and Harper**CREATION OF A STATE DEBT – BALTIMORE CITY – EAST BALTIMORE HISTORICAL LIBRARY**

Authorizing the creation of a State Debt in the amount of \$250,000, the proceeds to be used as a grant to the Board of Directors of the East Baltimore Community School, Inc. for specified development or improvement purposes related to the East Baltimore Historical Library, located in Baltimore City; providing for disbursement of the loan proceeds, subject to a requirement that the grantee provide and expend a matching fund; establishing a deadline for the encumbrance or expenditure of the loan proceeds; etc.

EFFECTIVE JUNE 1, 2014
