# **HOUSE BILLS INTRODUCED FEBRUARY 6, 2017**

#### HB 946 Delegate Anderton, et al

TRANSPORTATION – HIGHWAY USER REVENUES – DISTRIBUTION TO MUNICIPALITIES

Altering the authorized uses of highway user revenues; requiring that specified additional distributions of highway user revenues be made in specified fiscal years to Baltimore City and, under specified circumstances, municipalities; requiring that specified additional distributions of highway user revenues be allocated among municipalities in a specified manner; repealing obsolete distributions and transfers of highway user revenues for specified fiscal years; etc.

This bill requires a mandated appropriation in the annual budget bill.

# VEHICLE LAWS – VEHICLE PRESENCE MONITORING SYSTEMS – AUTHORIZATION BY LOCAL JURISDICTIONS

Authorizing and establishing requirements for the use of specified vehicle presence monitoring systems in local jurisdictions to enforce State and local laws restricting the presence of vehicles during specified times; establishing that a vehicle presence monitoring system may be used in a local jurisdiction under the Act only if its use is authorized by a local law adopted by the local jurisdiction; requiring the issuance of a warning for a first violation under the Act; etc.

Requiring the property management company of each senior apartment housing facility in Baltimore City to contract with a licensed security guard agency for the provision of security guard services at the senior apartment housing facility at all times that the property management company is not open for conducting business on the site of the senior apartment housing facility.

Altering specified provisions of the State procurement law relating to the debarment of specified persons engaged in investment activities in Iran to include persons participating in a boycott of the State of Israel; and altering specified provisions of law requiring the Board of Trustees for the State Retirement and Pension System to take divestment action with regard to investments in a company doing business in Iran or Sudan to include a company participating in a boycott of Israel.

Requiring the Board of Regents of the University System of Maryland, on a recommendation from the Chancellor, to establish general standards and guidelines for a collegiate recovery program to be implemented at the constituent institutions; requiring the president of each constituent institution, in collaboration with faculty, staff, and students enrolled at the institution, to develop and implement a collegiate recovery program tailored for the institution; requiring the program to include specified features; etc.

Requiring the Department of Labor, Licensing, and Regulation to establish procedures that require a foreclosure purchaser to send to the Department any updates to the information about or relating to the foreclosure purchaser that was submitted in the initial registration of a residential property with the Foreclosed Property Registry; and requiring the Department, for each registered residential property, to send to specified local governments a copy of the initial registration and any specified updates.

Requiring licensed physicians to maintain specified minimum amounts of professional liability insurance or attest to specified coverage as a condition of licensure and comply with specified regulations; requiring a licensed physician to notify the State Board of Physicians of the cancellation of the insurance or coverage within a specified time period; requiring a physician to provide the Board with specified verification or documentation on a specified application and at any other time on request of the Board; etc.

Authorizing the parent or legal guardian of a minor to delegate to a temporary health care agent the authority to consent and make decisions regarding medically necessary health care treatment of the minor; requiring a specified delegation to be made on a specified medical authorization treatment form; prohibiting a parent or legal guardian from delegating to a temporary health care agent the power to make specified decisions regarding life—sustaining treatment of the minor; etc.

Requiring the Maryland Transportation Authority to orally notify the registered owner of a motor vehicle that has incurred a video toll of the toll due if the video toll exceeds 100% of the original toll or the registered owner has outstanding video tolls in excess of \$250; establishing the amount of a civil penalty imposed for failing to pay a video toll at 25% of the video toll; prohibiting the Authority from referring a video toll to the Central Collection Unit for collection; etc.

Requiring the Governor to include \$100,000 in the State budget for fiscal year 2019 for the purpose of providing a grant to the William E. Kirwan Center for Academic Innovation at the University System of Maryland for the Maryland Open Source Textbook Initiative; requiring the Center and the State Department of Education to explore jointly the possibility of providing access to these types of learning materials and resources to students in primary and secondary education; etc.

This bill requires a mandated appropriation in the annual budget bill.

Requiring the Social Services Administration of the Department of Human Resources to establish a specified hotline to make specified reports of suspected child abuse or neglect; requiring the Administration to develop a specified methodology to track specified numbers and types of calls to a specified hotline; requiring the Administration to create a specified sign that contains information regarding a reporting suspicion of child abuse, child neglect, or child sexual abuse; etc.

Establishing that the requirement that a court order the Motor Vehicle Administration to suspend the driving privilege of a child for a specified period of time if the court finds that the child has unlawfully dispensed motor fuel into a dirt bike applies only to a child who is at least 15 years, 9 months old; repealing provisions of law governing the suspension of driving privileges for a child under the age of 15 years, 9 months for unlawfully dispensing motor fuel into a dirt bike; etc.

Requiring, for a development with 11 or more homes to be built by the same builder, a home builder to provide a purchaser with written information on energy–efficient options available for a new home; and requiring a contract for the initial sale of a new home to contain a specified acknowledgment that the purchaser was informed about specified energy–efficient options for the new home.

Requiring a specified business, when destroying an employee's or a former employee's records that contain specified personal information of the employee or former employee, to take specified steps to protect against unauthorized access to or use of the information; altering the circumstances under which a specified business that owns, licenses, or maintains computerized data that includes specified personal information must conduct a specified investigation and notify specified persons of a specified breach; etc.

Establishing the School Broadband Upgrade Grant Program; providing that the purpose of the Program is to provide State and local funding for special construction to leverage federal funds for category 1 and category 2 services that are available through a specified federal program to install or upgrade Internet access in every public school in the State; requiring the State Department of Education to administer the Program; etc.

Requiring nonelected members of boards and commissions in Frederick County to vacate office on becoming a candidate for an elected office, as specified; prohibiting a business entity, and a lawyer or lobbyist for the business entity, that has a pending bid or application before a county board or commission from making a contribution to candidates, as specified; requiring a campaign finance entity for a candidate to disclose a contribution within a specified time period; etc.

Authorizing the creation of a State Debt not to exceed \$250,000, the proceeds to be used as a grant to the Board of Directors of The National Steeplechase Foundation, Inc. for the acquisition, planning, design, construction, repair, renovation, reconstruction, site improvement, and capital equipping of the Fair Hill Race Course, located in Cecil County; providing for disbursement of the loan proceeds, subject to a requirement that the grantee provide and expend a matching fund; etc.

Requiring an educational accountability program to include at least three school quality indicators; prohibiting the school quality indicators from being based on student testing; requiring academic and school quality indicators to be given equal weight; requiring a county board of education to develop and implement a Comprehensive Support and Improvement Plan for specified schools under specified circumstances; etc.

#### PROPERTY TAX CREDIT – PUBLIC SAFETY OFFICERS

Authorizing the governing body of a county or municipal corporation to grant, by law, a specified property tax credit against the county or municipal corporation property tax imposed on a specified dwelling that is owned by a specified public safety officer under specified circumstances; providing that the credit may not exceed \$2,500 per dwelling and the amount of property tax imposed on the dwelling; etc.
