SENATE BILLS INTRODUCED February 8, 2017

SB 1019 Senator Cassilly, et al

DEPARTMENT OF COMMERCE – EMPLOYMENT IN THE STATE'S DEFENSE INDUSTRY – ARMY ALLIANCE STUDY

Requiring the Department of Commerce, in conjunction with the Department of Veterans Affairs and the Department of Labor, Licensing, and Regulation, to conduct a study on employment in the State's defense industry; specifying the minimum requirements of the study; requiring the Department of Commerce to consult with specified entities; requiring the Department of Commerce to report, on or before December 31, 2017, to the General Assembly on the findings of the study; etc.

MARYLAND HEALTH CARE REGULATORY REFORM ACT OF 2017

Reorganizing the Maryland Health Care Commission and the Health Services Cost Review Commission to be the Maryland Health Care and Cost Review Commission; repealing the Health Services Cost Review Commission, the Health Services Cost Review Commission Fund, and related provisions of law; requiring the Commission to submit to the Governor and General Assembly by January 1, 2018, a proposal for a streamlined certificate of need process and a specified list of health care facilities and services; etc.

ENTERPRISE ZONE AND REGIONAL INSTITUTION STRATEGIC ENTERPRISE ZONE PROGRAMS – SMALL BUSINESS ENTITIES

Allowing a credit against the State income tax for specified small business entities located in an enterprise zone or a Regional Institution Strategic Enterprise (RISE) zone; allowing a small business entity to claim the credit as a credit for the payment to the Comptroller of specified taxes; altering the definition of "qualified property" for purposes of a specified property tax credit on a specified assessment of specified real property located in a RISE zone so as to include specified personal property; etc.

REAL PROPERTY – VACANT AND ABANDONED PROPERTY – EXPEDITED FORECLOSURE

Authorizing a secured party to petition the circuit court for leave to immediately commence an action to foreclose the mortgage or deed of trust on specified vacant and abandoned property; authorizing a county, municipal corporation, homeowners association, or condominium to notify a secured party of any vacant and abandoned property located in the county, municipal corporation, homeowners association, or condominium in a specified manner; specifying the contents of a specified notice; etc.

SB 1023 Senator Zucker, et al

INDEPENDENT CONGRESSIONAL REDISTRICTING COMMISSION – MID–ATLANTIC STATES REGIONAL DISTRICTING PROCESS

Requiring the Department of Legislative Services to obtain specified census data, adjust the census data for specified purposes, and provide the census data to a temporary redistricting commission within a specified time period; creating a temporary redistricting commission; requiring the commission to use specified census data to prepare and adopt a districting plan for congressional districting within 90 days after the Commission members are appointed or the census data is received by the Commission, whichever is later; etc.

SB 1024 Senators McFadden and Ready

EDUCATION - GRANT FOR DECLINING EDUCATION AID

Establishing the criteria for a county board of education to be eligible to receive a specified State grant in fiscal year 2018; and specifying the calculation of a specified amount in a specified year for a specified purpose.

This bill requires a mandated appropriation in the annual budget bill.
