SENATE BILLS INTRODUCED February 14, 2017

SB 1062 Senator Nathan–Pulliam

CREATION OF A STATE DEBT – BALTIMORE CITY – MY BROTHER’S KEEPER

Authorizing the creation of a State Debt in the amount of \$280,000, the proceeds to be used as a grant to the Board of Trustees of the Irvington My Brother’s Keeper, Inc. for the acquisition, planning, design, construction, repair, renovation, reconstruction, site improvement, and capital equipping of the My Brother’s Keeper building, located in Baltimore City; providing for disbursement of the loan proceeds, subject to a requirement that the grantee provide and expend a matching fund; etc.

SB 1063 Senator Ramirez**CREATION OF A STATE DEBT – PRINCE GEORGE’S COUNTY – ST. ANN’S CENTER FOR CHILDREN, YOUTH AND FAMILIES**

Authorizing the creation of a State Debt not to exceed \$50,000, the proceeds to be used as a grant to the Board of Directors of St. Ann’s Center for Children, Youth and Families for the acquisition, planning, design, construction, repair, renovation, reconstruction, site improvement, and capital equipping of the Hope House at St. Ann’s Center for Children, Youth and Families, located in Prince George’s County; providing for disbursement of the loan proceeds, subject to a requirement that the grantee provide and expend a matching fund; etc.

SB 1064 Senator Waugh**CREATION OF A STATE DEBT – ST. MARY’S COUNTY – ST. MARY’S NURSING CENTER**

Authorizing the creation of a State Debt in the amount of \$250,000, the proceeds to be used as a grant to the Board of Trustees of St. Mary’s Nursing Center, Inc. for the acquisition, planning, design, construction, repair, renovation, reconstruction, site improvement, and capital equipping of the St. Mary’s Nursing Center facility, located in St. Mary’s County; providing for disbursement of the loan proceeds; etc.

SB 1065 Senator Manno, et al**TRANSPORTATION – I-270/US 15 MULTI-MODAL CORRIDOR STUDY AND WEST SIDE MOBILITY STUDY – REVIEW AND UPDATE**

Requiring specified Maryland Department of Transportation business entities to review and update the I-270/US 15 Multi-Modal Corridor Study and the West Side Mobility Study in order to ensure compliance with federal and State project development process requirements for the approval and funding of major public transportation projects; and requiring that a specified report be submitted on or before January 1 each year to specified committees until the completion of the review and update.

SB 1066 Senator Simonaire

CRIMINAL PROCEDURE – MODIFICATION OF SENTENCES

Authorizing the State to appeal a specified sentence modification to a three-judge review panel; authorizing a three-judge review panel to review a specified sentence modification; prohibiting a three-judge review panel from increasing a specified sentence in a specified manner; requiring that the court provide notice to the State if a three-judge review panel changes a specified sentence in a specified manner; and applying the Act retroactively.
