SENATE BILLS INTRODUCED March 6, 2017

SB 1172 Senator Bates

**ALCOHOLIC BEVERAGES – CLASS 5 BREWERIES – BARRELAGE
AND HOURS OF SALE**

Repealing the requirement that a local licensing board grant an on-site consumption permit under specified conditions; altering the amount of beer that a holder of a Class 5 brewery license may sell for on-premises consumption; and specifying hours of sale for beer sold for on-premises consumption, unless the hours are otherwise determined by the local licensing board for the jurisdiction in which the Class 5 brewery is located.

SB 1173 Senator Pinsky, et al**HIGHER EDUCATION DEGREE AND JOB CERTIFICATION WITHOUT DEBT ACT OF 2017**

Requiring the Governor to include \$250,000 in the State budget for fiscal years 2019 through 2023 for the Maryland Higher Education Commission to establish a near completer communication campaign; requiring the Commission to develop and implement a specified Web-based match program for near completers; establishing the Maryland Community College Promise Program to provide an opportunity for community college students to earn an associate's degree or certificate debt free; etc.

This bill requires a mandated appropriation in the annual budget bill.

SB 1174 Senator Jennings**PUBLIC HEALTH – CERTIFICATES OF BIRTH – BIRTHS OUTSIDE AN INSTITUTION**

Requiring the attending clinician or a designee of the attending clinician to prepare a certificate of birth, secure specified signatures, and file the certificate within 5 calendar days after a birth occurs outside an institution with an attending clinician; requiring the attending clinician, within 5 calendar days after the birth, to provide the date of birth and specified information that is required on a certificate of birth; etc.

SB 1175 Senator Benson**CREATION OF A STATE DEBT – PRINCE GEORGE’S COUNTY – TRANSIT ORIENTED DEVELOPMENT PUBLIC ART PROJECTS**

Authorizing the creation of a State Debt in the amount of \$280,000, the proceeds to be used as a grant to the Board of Directors of the Prince George’s Arts and Humanities Council, Inc. for the acquisition, planning, design, construction, repair, renovation, reconstruction, site improvement, and capital equipping of multiple transit oriented development public art projects, located in Prince George’s County; providing for disbursement of the loan proceeds; etc.

SB 1176 Senator Waugh**CREATION OF A STATE DEBT – ST. MARY’S COUNTY – MARYLAND DOVE**

Authorizing the creation of a State Debt in the amount of \$500,000, the proceeds to be used as a grant to the Historic St. Mary’s City Commission for the acquisition, planning, design, construction, repair, renovation, reconstruction, site improvement, and capital equipping of the vessel the Maryland Dove, located in St. Mary’s County; providing for disbursement of the loan proceeds; etc.

SB 1177 Senators Jennings and Norman**HARFORD COUNTY – ALCOHOLIC BEVERAGES – INTEREST IN MORE THAN ONE LICENSE**

Specifying that a percentage rent provision in a commercial lease does not constitute an interest in an alcoholic beverages license in Harford County.
