SB 1186 Senator Ferguson

CREATION OF A STATE DEBT – BALTIMORE CITY – CROSS STREET MARKET

Authorizing the creation of a State Debt not to exceed \$250,000, the proceeds to be used as a grant to the Mayor and City Council of Baltimore City for the acquisition, planning, design, construction, repair, renovation, reconstruction, site improvement, and capital equipping of the Cross Street Market, located in Baltimore City; providing for disbursement of the loan proceeds, subject to a requirement that the grantee provide and expend a matching fund; etc. EFFECTIVE JUNE 1, 2017 Assigned to: Budget and Taxation

CRIMINAL PROCEDURE – LIFE WITHOUT PAROLE – REPEAL OF SENTENCING PROCEEDING

Repealing specified provisions of law that provide a separate jury proceeding to determine whether a person convicted of murder in the first degree is sentenced to imprisonment for life without the possibility of parole or imprisonment for life; establishing that a court may sentence a person convicted of murder in the first degree to imprisonment for life without the possibility of parole without the requirement of a separate jury sentencing procedure under specified circumstances; applying the Act prospectively; etc.

Authorizing the creation of a State Debt not to exceed \$600,000, the proceeds to be used as a grant to the Board of Directors of The Bais Yaakov School for Girls, Inc. for the acquisition, planning, design, construction, repair, renovation, reconstruction, site improvement, and capital equipping of the Bais Yaakov Middle School facility, located in Baltimore County; providing for disbursement of the loan proceeds, subject to a requirement that the grantee provide and expend a matching fund; etc.

Authorizing the creation of a State Debt not to exceed \$188,000, the proceeds to be used as a grant to the Board of Directors of the Ner Israel Rabbinical College, Inc. for the acquisition, planning, design, construction, repair, renovation, reconstruction, site improvement, and capital equipping of emergency generators for the Ner Israel Rabbinical College facility, located in Baltimore County; providing for disbursement of the loan proceeds, subject to a requirement that the grantee provide and expend a matching fund; etc. EFFECTIVE JUNE 1, 2017
