PUBLIC SERVICE COMMISSION – APPLICATION FOR A CERTIFICATE OF PUBLIC CONVENIENCE AND NECESSITY – PUBLIC NOTICE AND HEARING

Requiring a certain notice made by the Public Service Commission or an applicant for a certificate of public convenience and necessity to be specific; requiring the Commission or a certain applicant to provide certain notice immediately to certain residents in a certain manner; requiring the Commission, at a certain time, to provide certain notice immediately of a certain application on certain Commission social media accounts, on the Commission's website in a certain manner, and through text alerts to certain interested persons; etc.

MARYLAND HEALTH CARE COMMISSION – MORTALITY RATES OF AFRICAN AMERICAN INFANTS AND INFANTS IN RURAL AREAS – STUDY

Requiring the Maryland Health Care Commission, in consultation with the Office of Minority Health and Health Disparities and interested stakeholders, to conduct a study on the mortality rates of African American infants and infants in rural areas; requiring the Commission to examine certain factors; requiring the Commission to report its findings and recommendations, including draft legislation establishing a permanent council on infant mortality in the State, to certain committees of the General Assembly by June 30, 2019; etc.

Prohibiting a pharmacy benefits manager from prohibiting a pharmacy or pharmacist from providing a beneficiary with certain information regarding the retail price of a prescription drug or the amount of the cost share for a prescription drug for which the beneficiary is responsible; prohibiting a pharmacy benefits manager from prohibiting a pharmacy or pharmacist from discussing with a beneficiary a certain retail price or certain cost share for a prescription drug; providing for the construction of the Act; etc.

Authorizing the Baltimore City Board of License Commissioners to require a certain mediation when a protest against renewing an alcoholic beverages license is filed at least 30 days before the license expires; authorizing the withdrawal or dismissal of a protest and the Board's approval or denial of a license renewal without a certain hearing if a required mediation results in a certain agreement; and requiring the Board to hold a certain hearing if a required mediation does not result in a certain agreement.
