HOUSE BILLS INTRODUCED JANUARY 11, 2018

HB 71 Delegate Krimm

PROGRAM OF ALL-INCLUSIVE CARE FOR THE ELDERLY (“PACE”) – LIMIT ON NUMBER OF PROVIDERS – PROHIBITION

Prohibiting the Maryland Department of Health from limiting the number of Program of All-Inclusive Care for the Elderly (“PACE”) providers that operate in the State if the providers otherwise meet the federal and State requirements for participation in the Program.

HB 72 **Delegate McKay****CREATION OF A STATE DEBT – WASHINGTON COUNTY – HANCOCK COMMUNITY POOL**

Authorizing the creation of a State Debt not to exceed \$100,000, the proceeds to be used as a grant to the Mayor and Town Council of the Town of Hancock for the acquisition, planning, design, construction, repair, renovation, reconstruction, site improvement, and capital equipping of a community pool for the Town of Hancock, located in Washington County; providing for disbursement of the loan proceeds, subject to a requirement that the grantee provide and expend a matching fund; etc.

HB 73 **Delegate Carr****VEHICLE LAWS – MULTIYEAR REGISTRATION**

Requiring, rather than authorizing, the Motor Vehicle Administration to adopt a system of multiyear vehicle registration; requiring that the system of multiyear vehicle registration adopted by the Administration include certain options for the duration of a registration; and requiring the Administration to make certain methods of obtaining or renewing a vehicle registration available for registration for 1-, 2-, and 3-year periods.

HB 74 **Delegate Grammer****EDUCATION – CAREER EXPLORATION AND DEVELOPMENT ACTIVITIES – COFFEE (JAVA ACT)**

Repealing a certain termination provision relating to prohibiting an Executive Branch agency from banning or regulating the sale of coffee in conjunction with a career exploration and development activity in certain public high schools.

HB 75 Delegate Angel**STATE BOARD OF COSMETOLOGISTS – DOMESTIC VIOLENCE AND SEXUAL ASSAULT AWARENESS TRAINING REQUIREMENTS**

Requiring the State Board of Cosmetologists to adopt regulations that establish certain curriculum standards for a certain domestic violence and sexual assault awareness course as part of a certain training program; requiring the Board to adopt regulations that set standards for a continuing education course that, at a minimum, requires an hour of domestic violence and sexual assault awareness training as a part of training in health, safety and welfare subjects; etc.

HB 76 Delegate Grammer**BALTIMORE COUNTY BOARD OF EDUCATION – EDUCATION TRANSPARENCY ACT**

Requiring that certain actions of the Baltimore County Board of Education be taken at a public meeting; requiring that any action of the county board be recorded by a verbal roll call vote of certain members of the county board; requiring the county board to keep a formal record of certain public meetings; requiring that any action of the county board be made publicly available on the county board's website within 12 hours of the time the action was taken; etc.

HB 77 Delegate Holmes**CONDOMINIUMS – CLAIMS AGAINST DEVELOPERS AND VENDORS – UNENFORCEABILITY OF CERTAIN PROVISIONS**

Making unenforceable certain provisions of certain condominium governing documents and other documents relating to asserting certain claims against a developer or vendor; applying the Act prospectively; etc.

HB 78 **Delegate Holmes****FORECLOSED PROPERTY REGISTRY – UPDATED INFORMATION – NOTICE TO LOCAL GOVERNMENTS**

Requiring the Department of Labor, Licensing, and Regulation to establish procedures that require a foreclosure purchaser to submit to the Foreclosed Property Registry any change to certain information within 21 days after the change is known to the purchaser; and requiring the Department to notify, by electronic means, on receipt of an initial registration or any change to certain information, authorized users from the county and the municipal corporation in which the property is located.

HB 79 **Delegate Grammer****OPIOID MAINTENANCE THERAPY PROGRAMS – LICENSE APPLICATIONS – NOTICE TO MEMBERS OF THE GENERAL ASSEMBLY**

Prohibiting the Secretary of Health from issuing a license to an opioid maintenance therapy program unless the Secretary gives notice of an application for a certain license by certified mail to each member of the General Assembly in whose district the opioid maintenance therapy program will be located before the Secretary issues the license; requiring the Department of Health to give the notice at least 30 days before the date of the approval of the license; etc.

HB 80 **Delegate Grammer****PUBLIC HEALTH – OPIOID MAINTENANCE THERAPY PROGRAMS –
LICENSE RENEWAL**

Authorizing a certain protest against the renewal of an opioid maintenance therapy program license by at least a certain number of certain persons; prohibiting the Secretary of Health, under certain circumstances, from approving a certain license renewal without holding a public hearing; requiring the Maryland Department of Health to post certain notice of a public hearing in a certain manner within a certain time frame; prohibiting the Secretary from approving the renewal of a certain license under certain circumstances; etc.

HB 81 **Delegate Angel****FAMILY LAW – CHILD ABUSE AND NEGLECT – MENTAL INJURY**

Altering the definition of “mental injury” to include the observable, identifiable, and substantial impairment of a child’s mental or psychological ability to function that results from the child’s exposure to an act that constitutes a certain crime of violence committed by a parent or household or family member against a parent or household or family member.
