HOUSE BILLS INTRODUCED FEBRUARY 26, 2018

HB 1772 Delegate McIntosh

TRANSPORTATION – PRIDE OF BALTIMORE II – FUNDING

Requiring the Governor to include in the annual State budget an appropriation of \$500,000 from the Transportation Trust Fund for the operation of the replica sailing vessel known as the Pride of Baltimore II.

This bill requires a mandated appropriation in the annual budget bill.

CREATION OF A STATE DEBT – WORCESTER COUNTY – POCOMOKE LITTLE LEAGUE

Authorizing the creation of a State Debt in the amount of \$75,000, the proceeds to be used as a grant to the Board of Directors of the Pocomoke Little League, Inc. for the acquisition, planning, design, construction, repair, renovation, reconstruction, site improvement, and capital equipping of field lights for the Pocomoke Little League baseball field, located in Worcester County; providing for disbursement of the loan proceeds, subject to a requirement that the grantee provide and expend a matching fund; etc.

HB 1774 Delegate Krimm, et al**TASK FORCE TO STUDY THE EFFECTIVENESS OF THE ENFORCEMENT OF RESTRICTIONS ON THE POSSESSION OF REGULATED FIREARMS**

Establishing a Task Force to Study the Effectiveness of the Enforcement of Restrictions on the Possession of Regulated Firearms; providing for the membership, staffing, and duties of the Task Force; requiring the Governor to appoint the chair of the Task Force; requiring the Task Force to make recommendations regarding whether existing laws are effective and adequately serve the public and report to the Governor and General Assembly by December 1, 2018; terminating the Act after June 30, 2019; etc.

Authorizing the creation of a State Debt not to exceed \$200,000, the proceeds to be used as a grant to the Board of Directors of Bishop McNamara High School, Inc. for the acquisition, planning, design, construction, repair, renovation, reconstruction, site improvement, and capital equipping of the gymnasium at Bishop McNamara High School, located in Prince George’s County; providing for disbursement of the loan proceeds, subject to a requirement that the grantee provide and expend a matching fund; etc.

Authorizing the creation of a State Debt not to exceed \$300,000, the proceeds to be used as a grant to the Board of Directors of the Alice Ferguson Foundation, Inc. for the acquisition, planning, design, construction, repair, renovation, reconstruction, site improvement, and capital equipping of the Potomac Watershed Study Center, located in Prince George’s County; providing for disbursement of the loan proceeds, subject to a requirement that the grantee provide and expend a matching fund; etc.
