HOUSE BILLS INTRODUCED MARCH 2, 2018

HB 1787 Delegate Ali

STATE GOVERNMENT – PREVENTION OF GENOCIDE AND CRIMES AGAINST HUMANITY AND THE COMMISSION ON GENOCIDE PREVENTION

Requiring the State Treasurer to ensure that any shares held by the State are voted in favor of shareholder resolutions that ask companies to adopt policies refusing to do business with governments engaging in genocide or crimes against humanity; requiring, when issuing an invitation for bids or a request for proposals, certain units of State government to require a certain bidder or offeror to disclose any company policy regarding a refusal to do business with governments that are engaged in genocide or crimes against humanity; etc.

HB 1788 Delegate Lam, et al**PUBLIC ETHICS LAW – OFFICIAL DUTIES – VIOLATIONS OF LAW**

Prohibiting an official or an employee from intentionally carrying out or neglecting an official duty or responsibility in a manner that violates certain statutes related to discrimination, hiring and termination, or holding office after an appointment or nomination under certain circumstances; making certain provisions of the Act contingent on the taking effect of another Act; and providing for the termination of certain provisions of the Act.

HB 1789 Delegate Mosby**CREATION OF A STATE DEBT – BALTIMORE CITY – LOVING ARMS HOMELESS YOUTH FACILITY**

Authorizing the creation of a State Debt in the amount of \$100,000, the proceeds to be used as a grant to the Board of Directors of Loving Arms, Inc. for the acquisition, planning, design, construction, repair, renovation, reconstruction, site improvement, and capital equipping of facilities for homeless youth, located in Baltimore City; providing for disbursement of the loan proceeds; etc.

HB 1790 Delegate Glenn**CREATION OF A STATE DEBT – BALTIMORE CITY – HARFORD ROAD ASSISTED LIVING AND MEDICAL ADULT DAY CARE CENTER**

Authorizing the creation of a State Debt not to exceed \$250,000, the proceeds to be used as a grant to the 6040 Harford ALF, LLC for the acquisition, planning, design, construction, repair, renovation, reconstruction, site improvement, and capital equipping of an assisted living and medical adult day care center, located in Baltimore City; providing for disbursement of the loan proceeds, subject to a requirement that the grantee provide and expend a matching fund; etc.

Authorizing the creation of a State Debt not to exceed \$200,000, the proceeds to be used as a grant to the Board of Trustees of the St. Elizabeth School, Inc. for the acquisition, planning, design, construction, repair, renovation, reconstruction, site improvement, and capital equipping of the St. Elizabeth School building, located in Baltimore City; providing for disbursement of the loan proceeds, subject to a requirement that the grantee provide and expend a matching fund; etc.

HB 1792 Chair, Health and Government Operations Committee (By Request – Departmental – Health)**MARYLAND DEPARTMENT OF HEALTH – DEPUTY SECRETARY FOR OPERATIONS AND DIRECTOR OF THE BEHAVIORAL HEALTH ADMINISTRATION – REPEAL OF POSITIONS**

Repealing the position of Deputy Secretary for Operations in the Maryland Department of Health; repealing the position of Director of the Behavioral Health Administration in the Maryland Department of Health; requiring the Deputy Secretary for Behavioral Health to perform the duties assigned to the former Director of the Behavioral Health Administration; etc.

HB 1793 Delegate Lafferty**CREATION OF A STATE DEBT – BALTIMORE COUNTY – MARYLAND EQUINE EDUCATION CENTER**

Authorizing the creation of a State Debt not to exceed \$250,000, the proceeds to be used as a grant to the Board of Trustees of Goucher College for the acquisition, planning, design, construction, repair, renovation, reconstruction, site improvement, and capital equipping of the Maryland Equine Education Center, located in Baltimore County; providing for disbursement of the loan proceeds, subject to a requirement that the grantee provide and expend a matching fund; etc.

HB 1794 Delegate Kaiser**CORPORATE INCOME TAX – SINGLE SALES FACTOR
APPORTIONMENT**

Altering the formula used to apportion income to the State for corporations that carry on a trade or business within and outside the State; repealing obsolete provisions; and applying the Act to taxable years beginning after December 31, 2018.

HOUSE JOINT RESOLUTION INTRODUCED MARCH 2, 2018**HJ 14 Delegate McComas, et al****SUPPORT FOR THE PEOPLE OF IRAN**

Expressing the support of the General Assembly for the people of Iran who are engaged in legitimate and peaceful protests; condemning the Iranian regime's serious human rights abuses against the Iranian people, significant corruption, and destabilizing activities abroad; noting certain statements of support for certain protesters and certain calls to support the Iranian people's right to live in a free society; demanding that the Iranian regime abide by its international obligations with respect to human rights and civil liberties; etc.
