HB 1806 Delegate Sanchez

CRIMINAL LAW – CRIMES RELATED TO LICENSED GAMING – PENALTIES

Prohibiting a person from cheating at a certain game; prohibiting a person from altering or misrepresenting the outcome of a certain game under certain circumstances; prohibiting a person from placing, increasing, or decreasing a bet or determining the course of certain play after acquiring certain knowledge; prohibiting a person from claiming, collecting, or taking or attempting to claim, collect, or take money or anything of value in or from a certain game, with intent to defraud, under certain circumstances; etc.

CRIMINAL LAW – THREAT OF MASS VIOLENCE AND DEADLY WEAPONS ON PUBLIC SCHOOL PROPERTY

Altering a certain prohibition relating to threatening to commit a certain crime of violence so as to prohibit a person from knowingly threatening to commit or threatening to cause to be committed a certain crime of violence that would place five or more minors at substantial risk of death or serious physical injury if the threat were carried out; altering and establishing certain penalties; etc.

CORRECTIONAL SERVICES – STATEWIDE INMATE RELEASE PROGRAMS – OFFICE OF ALTERNATIVES TO INCARCERATION

Establishing the Office of Alternatives to Incarceration within the Department of Public Safety and Correctional Services; providing for an executive director of the Office; authorizing the Secretary of the Department to provide the Office with certain employees; requiring the Office to adopt regulations to provide all inmates committed to the custody of local correctional facilities who are authorized to participate by a judge with a home detention program, work release program, pretrial release program, and a prerelease program; etc.

CREATION OF A STATE DEBT – ANNE ARUNDEL COUNTY – MARYLAND THEATRE FOR THE PERFORMING ARTS

Authorizing the creation of a State Debt not to exceed \$500,000, the proceeds to be used as a grant to the Board of Trustees of the Maryland Theatre for the Performing Arts, Inc. for the acquisition, planning, design, construction, repair, renovation, reconstruction, site improvement, and capital equipping of the Maryland Theatre for the Performing Arts facility, located in Anne Arundel County; providing for disbursement of the loan proceeds, subject to a requirement that the grantee provide and expend a matching fund; etc.

CREATION OF A STATE DEBT – BALTIMORE COUNTY – FREDERICK ROAD IMPROVEMENTS

Authorizing the creation of a State Debt not to exceed \$250,000, the proceeds to be used as a grant to the County Executive and County Council of Baltimore County for the acquisition, planning, design, construction, repair, renovation, reconstruction, site improvement, and capital equipping of improvements to Frederick Road, located in Baltimore County; providing for disbursement of the loan proceeds, subject to a requirement that the grantee provide and expend a matching fund; etc.
