#### **SB 618** Senator Klausmeier, et al

CAREER YOUTH AND PUBLIC SECTOR APPRENTICESHIP ACT

Requiring the State Board of Education to require a county board of education to award graduation credit to a high school student who completes work-based training or classroom instruction under a registered apprenticeship program; requiring the State Board to require a county board to count toward high school attendance the time certain apprentices spend during certain work-based training; requiring the Division of Workforce Development to make a certain annual report to the General Assembly by June 30; etc.

### HEALTH MAINTENANCE ORGANIZATIONS – CERTIFICATE OF NEED REQUIREMENTS – MODIFICATION

Repealing a certain requirement that a health maintenance organization or a certain health care facility have a certificate of need before taking certain actions to establish a certain ambulatory surgical facility or center; altering the conditions under which a health maintenance organization or a certain health care facility is required to have a certificate of need before taking certain action to establish a health care project; etc.

CORRECTIONAL OFFICERS' RETIREMENT SYSTEM – FORMER BALTIMORE CITY JAIL EMPLOYEES

Providing that certain former Baltimore City Jail employees who are members of the Correctional Officers' Retirement System and who meet certain criteria may receive a normal service retirement allowance that is based on certain service; and requiring the State Retirement Agency, on or before October 1, 2018, to notify certain individuals affected by the Act of their rights to apply certain service credit to the Correctional Officers' Retirement System. REAL PROPERTY – DELETION OF OWNERSHIP RESTRICTIONS BASED ON RACE, RELIGIOUS BELIEF, OR NATIONAL ORIGIN

Authorizing a person who holds an ownership interest in property that the person believes is subject to a certain unlawfully restrictive covenant to execute and record a restrictive covenant modification in a certain manner; requiring the governing body of a homeowners association to delete any recorded covenant or restriction that restricts ownership based on race, religious belief, or national origin from the deeds or other declarations of property in the development, on or before September 30, 2019; etc.

Authorizing the creation of a State Debt in the amount of \$130,000, the proceeds to be used as a grant to the Board of Directors of the Govans Ecumenical Development Corporation for the acquisition, planning, design, construction, repair, renovation, reconstruction, site improvement, and capital equipping of the Epiphany House, located in Baltimore City; providing for disbursement of the loan proceeds, subject to a requirement that the grantee provide and expend a matching fund; etc.

Authorizing the creation of a State Debt not to exceed \$100,000, the proceeds to be used as a grant to the Board of Directors of The Village Learning Place, Inc. for the acquisition, planning, design, construction, repair, renovation, reconstruction, site improvement, and capital equipping of the Village Learning Place building, located in Baltimore City; providing for disbursement of the loan proceeds, subject to a requirement that the grantee provide and expend a matching fund; etc.

# **SB 624** Senator Smith, et al

STATE INCOME AND PROPERTY TAX CREDITS – PURPLE LINE CONSTRUCTION ZONE

Allowing certain businesses impacted by the construction of the Purple Line light rail project in Montgomery County and Prince George's County a credit against the State income tax and State property tax; requiring the Department of Transportation, in consultation with the Comptroller, to determine the amount of the income tax credit; requiring the Department to certify a business entity as a qualified business if the business entity can establish loss of business income at a property in the area impacted by the construction; etc. EFFECTIVE JUNE 1, 2018 TG, § 10-746 and TP, § 9-111 - added Assigned to: Budget and Taxation

# **SB 625** Senator Smith

### CRIMINAL PROCEDURE – MEDICAL EMERGENCY – IMMUNITY

Altering a provision of law to specify that a person who is experiencing a medical emergency, rather than a person who reasonably believes that the person is experiencing a medical emergency, after ingesting or using alcohol or drugs is immune from criminal arrest, charge, or prosecution for a certain violation if the evidence for the arrest, charge, or prosecution was obtained solely as a result of the person seeking or receiving medical assistance; etc. EFFECTIVE OCTOBER 1, 2018 CP, § 1-210 - amended

VEHICLE REGISTRATION – EXEMPTION FROM REGISTRATION FEES – SURVIVING SPOUSES OF VETERANS

Repealing the requirement that the surviving spouse of a deceased disabled veteran be at least 65 years old to qualify for a certain exemption to vehicle registration fees.

Authorizing the creation of a State Debt not to exceed \$150,000, the proceeds to be used as a grant to the Board of Directors of Gandhi Brigade Incorporated for the acquisition, planning, design, construction, repair, renovation, reconstruction, site improvement, and capital equipping of a digital media lab for the Gandhi Brigade Youth Media program, located in Montgomery County; providing for disbursement of the loan proceeds, subject to a requirement that the grantee provide and expend a matching fund; etc.

#### **SB 628** Senators Smith and Benson

CRIMINAL LAW – ALCOHOL OFFENSES AND GAMING – CIVIL OFFENSES

Making it a civil rather than a criminal offense to consume an alcoholic beverage in public under certain circumstances or to possess an alcoholic beverage in an open container under certain circumstances; requiring certain offenders to be issued a citation under certain circumstances; providing a certain maximum fine of \$100; altering the penalty for certain conduct relating to betting, wagering, or gambling; making certain conduct relating to betting, wagering, or gambling; making certain conduct relating to betting, wagering, or gambling; making certain conduct relating to betting, wagering, or gambling a civil offense; etc.

Requiring each local correctional facility and each correctional facility in the Department of Public Safety and Correctional Services to have a written policy in place regarding the medical care of pregnant inmates that addresses certain matters; requiring the managing official of each correctional facility to provide the written policy to an inmate at a certain time; requiring the Maryland Commission on Correctional Standards to review each correctional facility's policy during regular inspections; etc.

#### NURSING HOMES – PARTIAL PAYMENT FOR SERVICES PROVIDED

Requiring the Maryland Department of Health to make a certain advance payment to a nursing home at the request of the nursing home for uncompensated Maryland Medical Assistance Program services provided to a certain resident; providing that the advance payment may not exceed 50% of the estimated amount due for the uncompensated services; requiring the Department to pay the balance due to a nursing home under certain circumstances; etc.

HIGHER EDUCATION OUTREACH AND COLLEGE ACCESS PROGRAM – ALTERATIONS AND REPEAL OF SUNSET

Repealing the termination date of certain provisions of law relating to the Maryland Higher Education Outreach and College Access Pilot Program; altering the name of the Program; and altering the provisions related to a certain report on the Program.

Requiring the Governor to include in the annual budget bill for fiscal years 2020 and 2021 an appropriation of \$3,750,000 for the Maryland Smart Growth Investment Fund; providing that the Governor is not required to include the appropriation in the fiscal year 2020 annual budget bill if on March 1, 2018, the Fund balance is less than \$25,000,000 and in the fiscal year 2021 annual budget bill if on July 1, 2019, the Fund balance is less than \$25,000,000; etc. This bill requires a mandated appropriation in the annual budget bill.

Authorizing the creation of a State Debt in the amount of \$400,000, the proceeds to be used as a grant to the Board of Directors of the Govans Ecumenical Development Corporation for the acquisition, planning, design, construction, repair, renovation, reconstruction, site improvement, and capital equipping of the Harford House, located in Baltimore City; providing for disbursement of the loan proceeds, subject to a requirement that the grantee provide and expend a matching fund; etc. EFFECTIVE JUNE 1, 2018

# **SB 634** Senator Hershey

CREATION OF A STATE DEBT – QUEEN ANNE'S COUNTY – COMPASS REGIONAL HOSPICE

Authorizing the creation of a State Debt not to exceed \$250,000, the proceeds to be used as a grant to the Board of Directors of the Compass Regional Hospice, Inc. for the acquisition, planning, design, construction, repair, renovation, reconstruction, site improvement, and capital equipping of the Compass Regional Hospice facility, located in Queen Anne's County; providing for disbursement of the loan proceeds, subject to a requirement that the grantee provide and expend a matching fund; etc.

# **SB 635** Senator Hershey

DRIVER'S LICENSES AND IDENTIFICATION CARDS – NOTATION FOR LIFE–THREATENING ALLERGY

Requiring the Motor Vehicle Administration to ensure that the driver's license or identification card of an applicant who indicates on a certain application that the applicant has a life-threatening allergy includes a notation specifying that allergy; requiring an application for a driver's license or an identification card to allow an applicant to indicate that the applicant has a life-threatening allergy and specify the life-threatening allergy; and authorizing the Administration to adopt certain regulations.

CECIL COUNTY – OFFICE OF THE SHERIFF – EMPLOYEES AND COLLECTIVE BARGAINING

Altering the period of time for which certain employees of the Office of the Sheriff of Cecil County are required to serve a probationary period; altering which deputy sheriffs in the Office have the right to organize and collectively bargain with the Sheriff and the Cecil County Executive with regard to certain wages, benefits, and working conditions; correcting certain references to the government of Cecil County and to a certain position in the Office; etc. EFFECTIVE JULY 1, 2018 CJ, § 2-309(i) - amended Assigned to: Judicial Proceedings

#### **SB 637** Cecil County Senators

CORRECTIONAL SERVICES – CECIL COUNTY – RELEASE AND HOME DETENTION PROGRAMS

Repealing certain provisions of law relating to the establishment and administration of a home detention program by the Sheriff of Cecil County; authorizing the Sheriff to establish and administer programs for home detention, prerelease, pretrial release, and work release; requiring the Sheriff to adopt regulations to implement each program; authorizing a court to allow an individual to participate in a certain program under certain circumstances; etc. EFFECTIVE OCTOBER 1, 2018

#### **SB 638** Senator Conway, et al

TEACHERS AND TEACHER PREPARATION PROGRAMS – RESEARCH–BASED READING INSTRUCTION

Requiring the Professional Standards and Teacher Education Board, on or before January 1, 2022, to require a candidate for a certificate to teach certain students to pass a test of research–based reading instruction; requiring the Board and the State Board of Education jointly to select the test and set the passing score for the test, subject to a certain condition; requiring the Board and the State Board jointly to set standards for the delivery of research–based reading instruction by teacher preparation programs in the State; etc.

Altering certain procedures for suspending or dismissing certain public school personnel; authorizing certain public school personnel to request a hearing before the county board or arbitration under certain circumstances; specifying the procedures for arbitration; assigning responsibility to the individual for 50% of the cost and expenses of the arbitration and 50% to the county board; providing that an arbitrator's decision and award is final and binding on the parties, subject to review by a circuit court; etc. Preliminary analysis: local government mandate EFFECTIVE OCTOBER 1, 2018

Authorizing the creation of a State Debt not to exceed \$175,000, the proceeds to be used as a grant to the Board of Trustees of PHILLIPS Programs Incorporated for the acquisition, planning, design, construction, repair, renovation, reconstruction, site improvement, and capital equipping of a commercial kitchen at PHILLIPS School, located in Howard County; providing for disbursement of the loan proceeds, subject to a requirement that the grantee provide and expend a matching fund; etc. EFFECTIVE JUNE 1, 2018

# **SB 641** Howard County Senators

CREATION OF A STATE DEBT – HOWARD COUNTY – ELLICOTT CITY PUBLIC ARTS PROJECT HO. CO. 2–18

Authorizing the creation of a State Debt in the amount of \$175,000, the proceeds to be used as a grant to the Board of Directors of the Ellicott City Historic District Partnership, Incorporated for the acquisition, planning, design, construction, repair, renovation, reconstruction, site improvement, and capital equipping of a mural for the Ellicott City Public Arts Project, located in Howard County; providing for disbursement of the loan proceeds, subject to a requirement that the grantee provide and expend a matching fund; etc. EFFECTIVE JUNE 1, 2018

#### **SB 642** Howard County Senators

CREATION OF A STATE DEBT – HOWARD COUNTY – GATEWAY INNOVATION CENTER HO. CO. 3–18

Authorizing the creation of a State Debt not to exceed \$350,000, the proceeds to be used as a grant to the Board of Directors of the Howard County Economic Development Authority for the acquisition, planning, design, construction, repair, renovation, reconstruction, site improvement, and capital equipping of the Gateway Innovation Center, located in Howard County; providing for disbursement of the loan proceeds, subject to a requirement that the grantee provide and expend a matching fund; etc.

Authorizing the creation of a State Debt not to exceed \$250,000, the proceeds to be used as a grant to the Maryland–National Capital Park and Planning Commission for the acquisition, planning, design, construction, repair, renovation, reconstruction, site improvement, and capital equipping of the Black Hill SEED Classroom building, located in Montgomery County; providing for disbursement of the loan proceeds, subject to a requirement that the grantee provide and expend a matching fund; etc.

Prohibiting a person in Allegany County from operating an all-terrain vehicle or snowmobile on controlled access highways; authorizing a local authority in Allegany County to authorize a person to cross a highway at a right angle on an all-terrain vehicle or snowmobile when operated at not more than 25 miles per hour; authorizing a local authority in Allegany County to authorize the operation of a snowmobile or an all-terrain vehicle on a certain portion of highway when operated at not more than 25 miles per hour; etc. EFFECTIVE OCTOBER 1, 2018 TR, § 21-104.1 and 25-102(a)(14) - amended

ALLEGANY COUNTY – ALCOHOLIC BEVERAGES – CLASS B–TM (THEATER/MUSEUM) LICENSE

Establishing a Class B–TM (theater/museum) beer, wine, and liquor license in Allegany County; authorizing the Board of License Commissioners to issue the license for use by a theater/museum that has a ballroom with a maximum seating capacity of 300 per event; establishing that the license authorizes the license holder to sell at retail beer, wine, and liquor for on–premises consumption and in conjunction with certain events; establishing the hours and days for sale for the license; setting a \$350 fee; etc.

Altering a certain limit on the unified credit used for determining the Maryland estate tax for certain decedents; and altering a certain limitation on the amount of the Maryland estate tax for decedents dying on or after January 1, 2019. EFFECTIVE JULY 1, 2018 TG, § 7-309(b)(1), (2), and (3) - amended Assigned to: Budget and Taxation

EARNED INCOME TAX CREDIT – INDIVIDUALS WITHOUT QUALIFYING CHILDREN – EXPANSION

Altering the calculation of the Maryland earned income tax credit to allow certain individuals without qualifying children to claim an increased credit; expanding eligibility of the credit to allow certain individuals without certain qualifying children to claim the credit; allowing certain individuals to claim the credit without regard to a certain age limitation; applying the Act to taxable years beginning after December 31, 2017; etc.

REAL PROPERTY – NEW HOME SALES – INFORMATION ON ENERGY–EFFICIENT OPTIONS

Requiring, for a development with 11 or more homes to be built by the same builder, a home builder to provide a purchaser with written information on energy–efficient options, including a statement that tax credits may be available related to the energy–efficient options, available for installation in a new home; and requiring a contract for the initial sale of a new home to contain a certain acknowledgment that the purchaser was provided with certain information about energy–efficient options for the home.

Repealing certain provisions of law relating to a surviving spouse making an election to take a certain share of the net estate of the decedent instead of the property left to the surviving spouse under the will; providing that a surviving spouse may take a certain elective share amount of a certain estate subject to election; establishing the priority to be used in determining the sources from which a certain elective share amount is payable; etc.

Increasing, from \$2,500 to \$5,000, the amount of a subtraction modification under the Maryland income tax for contributions made by certain individuals whose federal adjusted gross income does not exceed \$225,000 or, in the case of a single individual or a married individual filing a separate return, \$150,000 to certain college savings plan accounts; applying the Act to taxable years beginning after December 31, 2017; etc.

Prohibiting a person from selling in the State a certain expanded polystyrene food service product on or after January 1, 2019; prohibiting certain food service businesses and certain schools from selling or providing food in certain expanded polystyrene food service products on or after January 1, 2019; requiring a county health department to impose certain penalties for violations of the Act; requiring a county health department to notify the Department of the Environment of certain violations; etc.

# COLLECTIVE BARGAINING – MEMORANDUM OF UNDERSTANDING – CONTINUATION

Prohibiting a memorandum of understanding agreed to and ratified under certain provisions of law from expiring until it is succeeded by a memorandum of understanding agreed to and ratified under a certain provision of the law; requiring that the terms of a certain memorandum of understanding continue in force and effect until a certain memorandum of understanding is agreed to and ratified; authorizing an exclusive representative to file a certain action in a circuit court under certain circumstances; etc.
