## SENATE BILLS INTRODUCED February 12, 2018

### **SB 1079 Senator Mathias**

#### PHARMACY BENEFITS MANAGERS – REVISIONS

Altering the application fee for a pharmacy benefits manager to register with the Maryland Insurance Commissioner; prohibiting a pharmacy benefits manager from prohibiting a pharmacy or pharmacist from providing a beneficiary with certain information regarding a certain retail price or certain cost share for a prescription drug; prohibiting a pharmacy benefits manager from retaliating against a contracted pharmacy for filing a certain complaint; prohibiting a pharmacy benefits manager from charging a certain fee; etc.

**SB 1080 Senator Muse****ASSEMBLY AREAS – STATE-FUNDED CONSTRUCTION OR RENOVATION – ASSISTIVE LISTENING SYSTEM REQUIREMENT**

Requiring certain recipients of State funds to install an assistive listening system in an assembly area during construction or renovation of the assembly area under certain circumstances; requiring the Department of General Services to establish a certain waiver process and a certain penalty process relating to the requirement to install an assistive listening system in an assembly area during construction or renovation of the assembly area; authorizing the Department to adopt certain regulations; etc.

**SB 1081 Senators Astle and Feldman****BUSINESS REGULATION – LIMITED RESIDENTIAL LODGING**

Requiring innkeepers and hosting platform operators offering certain types of limited residential lodging to operate in a certain manner; requiring that certain records be made available to the Comptroller, the Department of Labor, Licensing, and Regulation, a law enforcement agency, a county, or a municipality; authorizing certain entities to order an innkeeper to cease and desist from offering certain lodging; providing that a hosting platform operator may not facilitate booking transactions except under certain circumstances; etc.

## STATE GOVERNMENT – REGULATIONS IMPACTING SMALL BUSINESSES – ECONOMIC IMPACT ANALYSES

Requiring the Office of Legislative Audits to conduct a performance audit of certain units of State government every 3 years for certain purposes; requiring certain units to make a certain determination regarding certain local regulations; requiring certain units to establish a certain electronic registry and to post on the registry a proposed regulation that has a significant small business impact; requiring certain units to create certain compliance guides to assist small businesses to comply with certain regulations; etc.

## PUBLIC HEALTH – PRESCRIPTION DRUG MONITORING PROGRAM – REVISIONS

Requiring, instead of authorizing, the Prescription Drug Monitoring Program to review prescription monitoring data for indications of a possible misuse or abuse of a monitored prescription drug; requiring, instead of authorizing, the Program to report the possible misuse or abuse to the prescriber or dispenser of the monitored prescription drug under certain circumstances; requiring the Program to provide education to the prescriber or dispenser of the monitored prescription drug under certain circumstances; etc.

**SB 1084 Senator Conway (By Request – Baltimore City Administration), et al****BALTIMORE CITY – CONTINUING THE CREATING OPPORTUNITIES FOR RENEWAL AND ENTERPRISE (CORE) PARTNERSHIP FUND**

Establishing the Continuing the CORE Partnership Fund to assist the Department of Housing and Community Development, in conjunction with the Maryland Stadium Authority and Baltimore City, in expeditiously removing blighted property within Baltimore City; requiring the Secretary to administer the Fund; specifying the contents of the Fund; requiring the Governor to include at least \$30,000,000 in the annual budget bill for the Fund for fiscal year 2020 and \$25,000,000 for the Fund in fiscal years 2021 through 2024; etc.

This bill requires a mandated appropriation in the annual budget bill.

**SB 1085 Senator Conway (By Request – Baltimore City Administration), et al****BALTIMORE CITY – TOURISM IMPROVEMENT DISTRICT**

Authorizing the Mayor and City Council of Baltimore to establish by ordinance a certain Tourism Improvement District; authorizing the Mayor and City Council to designate a Tourism Improvement District Association to provide certain services; requiring the Association to establish a certain financial plan for the District; prohibiting the Mayor and city Council from authorizing certain reductions in certain existing funding; providing that certain unspent funds be refunded to certain business owners in a certain manner; etc.

EFFECTIVE OCTOBER 1, 2018

**SB 1086 Senators Lee and Madaleno****CREATION OF A STATE DEBT – MONTGOMERY COUNTY – JOSIAH HENSON PARK**

Authorizing the creation of a State Debt not to exceed \$500,000, the proceeds to be used as a grant to the Maryland–National Capital Park and Planning Commission for the acquisition, planning, design, construction, repair, renovation, reconstruction, and capital equipping of the Josiah Henson Park, located in Montgomery County; providing for disbursement of the loan proceeds, subject to a requirement that the grantee provide and expend a matching fund; etc.

**SB 1087 Senator Zucker****STATE BOARD OF PHYSICIANS – INVASIVE CARDIOVASCULAR PROFESSIONALS**

Authorizing certain registered cardiovascular invasive specialists to perform certain functions; requiring a registered cardiovascular invasive specialist to be supervised by a licensed physician; establishing that the failure of certain licensed physicians to provide proper supervision constitutes professional misconduct; requiring the State Board of Physicians to keep a list of all cardiovascular invasive specialists and adopt certain regulations; etc.

**SB 1088 Senator King****CREATION OF A STATE DEBT – MONTGOMERY COUNTY – GERMANTOWN BANK MUSEUM**

Authorizing the creation of a State Debt in the amount of \$200,000, the proceeds to be used as a grant to the Board of Directors of The Germantown Historical Society, Inc. for the acquisition, planning, design, construction, repair, renovation, reconstruction, and capital equipping of the Germantown Bank Museum building, located in Montgomery County; providing for disbursement of the loan proceeds, subject to a requirement that the grantee provide and expend a matching fund; etc.

**SB 1089 Senator Zucker****CREATION OF A STATE DEBT – MONTGOMERY COUNTY – SANDY SPRING ODD FELLOWS LODGE**

Authorizing the creation of a State Debt in the amount of \$15,000, the proceeds to be used as a grant to the Board of Directors of the Grand United Order of Oddfellows Sandy Spring Lodge #6430, Inc. for the acquisition, planning, design, construction, repair, renovation, reconstruction, and capital equipping of the Sandy Spring Odd Fellows Lodge, located in Montgomery County; providing for disbursement of the loan proceeds; etc.

**SB 1090** Senators Peters and GuzzoneCORPORATE INCOME TAX – SINGLE SALES FACTOR  
APPORTIONMENT

Altering the formula used to apportion certain income to the State for certain corporations that carry on a trade or business within and outside the State; authorizing certain corporations to elect to use a certain formula to apportion certain income; repealing obsolete provisions; and applying the Act to all taxable years beginning after December 31, 2017.
