SENATE BILLS INTRODUCED February 23, 2018

SB 1202 Senator Peters, et al

HIGHER EDUCATION – RICHARD W. COLLINS III LEADERSHIP WITH HONOR SCHOLARSHIP – ESTABLISHMENT

Establishing the Richard W. Collins III Leadership With Honor Scholarship Program; establishing eligibility criteria for the scholarship that requires an individual to be a member of the Reserve Officer Training Corps, a certain minority student, and a student at a historically black college or university; requiring the Office of Student Financial Assistance in the Maryland Higher Education Commission to award 25% of its grant money to students at Bowie State University and 75% to certain other colleges and universities; etc.

This bill requires a mandated appropriation in the annual budget bill.

SB 1203 Senator Kagan**HIGHER EDUCATION – SEXUAL ASSAULT RESPONSE TRAINING – REQUIREMENTS AND GRANT PROGRAM**

Requiring each institution of higher education, beginning in the 2018–2019 academic year, to annually provide certain sexual assault response training to certain employees, contractors, or enrolled students who may be involved in certain actions; requiring each institution of higher education to provide certain training for a minimum of 8 hours to certain employees; authorizing the institution of higher education to combine certain required training; requiring certain training to include certain information; etc.

This bill requires a mandated appropriation in the annual budget bill.

SB 1204 Senator Robinson**BALTIMORE CITY – EDUCATION – JUNIOR RESERVE OFFICER TRAINING CORPS INSTRUCTORS**

Altering the definition of “public school employee” for Baltimore City to include Junior Reserve Officer Training Corps (JROTC) instructors for the purpose of authorizing collective bargaining for JROTC instructors.

SB 1205 Senator Eckardt**MARYLAND INSURANCE COMMISSIONER – AUTHORITY TO ADOPT REGULATIONS – PHARMACY BENEFITS MANAGERS**

Clarifying that the Maryland Insurance Commissioner has the authority to adopt regulations to carry out certain provisions of law governing pharmacy benefits managers; and repealing a certain provision of law rendered obsolete by a certain provision of the Act.

SB 1206 Senator Kasemeyer

TRANSPORTATION – PRIDE OF BALTIMORE II – FUNDING

Requiring the Governor to include in the annual State budget an appropriation of \$500,000 from the Transportation Trust Fund for the operation of the replica sailing vessel known as the Pride of Baltimore II.

This bill requires a mandated appropriation in the annual budget bill.

SB 1207 Senator KlausmeierWORKERS' COMPENSATION – TEMPORARY PARTIAL DISABILITY –
CONCURRENT EMPLOYMENT

Authorizing a covered employee, during the time the employee is receiving temporary partial disability benefits as a result of an accidental personal injury or occupational disease, to earn wages, under certain circumstances, from concurrent employment in which the covered employee was engaged at the time that the accidental personal injury or occupational disease occurred; etc.
