SENATE BILL INTRODUCED February 23, 2018

SB 1208 Senators Klausmeier and Mathias

SENIOR PRESCRIPTION DRUG ASSISTANCE PROGRAM – SUNSET EXTENSION AND REPEAL OF SUBSIDY FOR MEDICARE PART D COVERAGE GAP

Extending to December 31, 2024, the termination date of the Senior Prescription Drug Assistance Program; altering the period of time during which the subsidy required under the Program may not exceed a certain amount; repealing the requirement that the Program annually provide a certain subsidy of up to the full amount of the Medicare Part D coverage gap; etc.

REAL PROPERTY – REGULATION OF COMMON OWNERSHIP COMMUNITY MANAGERS

Creating the State Board of Common Ownership Community Managers in the Department of Labor, Licensing, and Regulation; providing for the composition of the Board and the appointment, terms, and expenses of the Board members; providing that the Act does not prohibit certain persons from providing services under certain circumstances; requiring an individual to be issued a license or a limited license by the Board before providing management services for a common ownership community under certain circumstances; etc. EFFECTIVE OCTOBER 1, 2018

CRIMINAL PROCEDURE – EXTRADITION – DUTY OF LOCAL GOVERNMENTS (SANCTUARY FOR CITIZENS ACT)

Establishing that it is the duty of the governing body of every county and municipal corporation in the State to have arrested and delivered up to the executive authority of any federal agency any person for whom there is a valid judicial, civil, or criminal federal warrant and who is found in the State; and requiring counties and qualifying municipalities to comply with certain provisions of law in order to receive certain aid from the State.

VEHICLE LAWS – OPERATING VEHICLE WHILE ANIMAL ON DRIVER'S SEAT – PROHIBITION

Prohibiting an individual from operating a motor vehicle while an animal is on the driver's seat.

CRIMINAL PROCEDURE – EXPUNGEMENT – EXPANSION (MARYLAND RECORD EXPUNGEMENT DESIGNED TO ENHANCE EMPLOYMENT (REDEEM) ACT OF 2018)

Authorizing a person who is the subject of a certain warrant to file a certain petition for expungement; providing that a person who, on or after October 1, 2018, has been charged with the commission of a certain crime, has been charged with a certain civil offense or infraction, or is the subject of a certain warrant is entitled to automatic expungement of certain records under certain circumstances; specifying that certain dispositions are eligible for automatic expungement at certain times; etc.

PUBLIC SCHOOLS – STUDENT DISCIPLINE – SUSPENSIONS AND EXPULSIONS

Requiring the county superintendent of schools or the county superintendent's designated representative, when making a decision to extend a student's suspension, to complete a certain investigation by the 10th day of a student's initial suspension; requiring a certain student to return to school after a suspension if a certain investigation has not been completed within a certain period of time except under certain circumstances; requiring a county board to provide access to a certain student to the student's assignments; etc.

CREATION OF A STATE DEBT – BALTIMORE CITY – ST. ELIZABETH SCHOOL

Authorizing the creation of a State Debt not to exceed \$200,000, the proceeds to be used as a grant to the Board of Trustees of the St. Elizabeth School, Inc. for the acquisition, planning, design, construction, repair, renovation, reconstruction, site improvement, and capital equipping of the St. Elizabeth School building, located in Baltimore City; providing for disbursement of the loan proceeds, subject to a requirement that the grantee provide and expend a matching fund; etc.

CREATION OF A STATE DEBT – WICOMICO COUNTY – ROTARY LABYRINTH

Authorizing the creation of a State Debt not to exceed \$100,000, the proceeds to be used as a grant to the Board of Trustees of the Rotary Club of Salisbury Foundation, Inc. for the acquisition, planning, design, construction, repair, renovation, reconstruction, site improvement, and capital equipping of the Rotary Labyrinth project, located in Wicomico County; providing for disbursement of the loan proceeds, subject to a requirement that the grantee provide and expend a matching fund; etc.
