SENATE BILLS INTRODUCED March 1, 2018

SB 1224 Senator Serafini

PROCUREMENT – PREVAILING WAGE – MODIFICATIONS

Altering the definition of “public body” to increase, from 25% to 50%, the percentage of money used for construction that must be State money for a certain entity or person to be included with respect to the construction of an elementary or secondary school for purposes of certain provisions of law governing the prevailing wage; authorizing the Commissioner of Labor and Industry to set regional prevailing wage rates for each classification of worker engaged in work of the same or similar character for certain regions; etc.

SB 1225 Senator AstleANNE ARUNDEL COUNTY – SHORT-TERM RESIDENTIAL RENTALS
– TAXATION AND REGULATION

Imposing the Anne Arundel County hotel occupancy tax on certain consideration paid for the use or occupancy of a short-term residential rental in the county; providing for the administration and collection of the Anne Arundel County hotel occupancy tax on short-term residential rentals; prohibiting a person from operating a short-term residential rental without a license; authorizing certain short-term residential rentals as a conditional use allowed in certain residential districts; etc.

SENATE BILL INTRODUCED *February 28, 2018***SB 1226** Senator Jennings, et alPRIMARY AND SECONDARY SCHOOLS – ARMED SCHOOL
RESOURCE OFFICERS

Requiring each public school to have an armed school resource officer present on school grounds during regular school hours on school days; requiring the Department of State Police to assign a State Police officer to a certain public school under certain circumstances; requiring a certain State Police officer to be present on school grounds during regular school hours on school days and to carry a firearm; and authorizing a private school to have an armed school resource officer present on school grounds.

SENATE BILLS INTRODUCED March 1, 2018**SB 1227 Senator Ready****STATE EDUCATION AID – MANDATED EDUCATIONAL REQUIREMENTS – COUNTY BOARD OPT-OUT**

Providing that if less than 45% of a county board's 3-year moving average annual budget is funded by the State, the county board may, in the following school year, opt out of certain mandated educational requirements; requiring certain county boards to follow federally mandated education requirements; etc.

SB 1228 Senator Nathan–Pulliam**CREATION OF A STATE DEBT – BALTIMORE CITY – SHAKE AND BAKE FAMILY FUN CENTER**

Authorizing the creation of a State Debt not to exceed \$250,000, the proceeds to be used as a grant to the Mayor and City Council of the City of Baltimore for the acquisition, planning, design, construction, repair, renovation, reconstruction, site improvement, and capital equipping of the Shake and Bake Family Fun Center, located in Baltimore City; providing for disbursement of the loan proceeds, subject to a requirement that the grantee provide and expend a matching fund; etc.

SB 1229 Senator Robinson**PUBLIC INSTITUTIONS OF HIGHER EDUCATION – FAMILY MEMBERS OF KILLED OR DISABLED FIRST RESPONDERS – TUITION EXEMPTION (SEAN SUITER ACT)**

Exempting a family member of a certain first responder who was killed or disabled in the line of duty from paying tuition and certain fees at a public institution of higher education; and defining the term “family member” as a spouse, domestic partner, or child.

TASK FORCE TO INVESTIGATE THE CHALLENGES OF AND OPPORTUNITIES FOR MINORITIES IN BUSINESS – REPORT AND SUNSET EXTENSION

Altering the date to December 31, 2018, rather than 2017, by which the Task Force to Investigate the Challenges of and Opportunities for Minority Business is required to report its findings and recommendations to the Governor and the General Assembly; and extending the termination date of the Task Force for an additional year to June 30, 2019.

SB 1231 Senator Madaleno, et al

HUMAN SERVICES – TEMPORARY DISABILITY ASSISTANCE PROGRAM

Establishing the Temporary Disability Assistance Program in the Department of Human Services; requiring the Family Investment Administration to be the central coordinating and directing agency of the Program; requiring the Program to be administered by the local departments of social services in a certain manner; specifying the requirements for eligibility for the Program; requiring an application for the Program to include a certain medical report; establishing certain restrictions on the length of eligibility periods; etc.

This bill requires a mandated appropriation in the annual budget bill.

CREATION OF A STATE DEBT – FREDERICK COUNTY – THE RANCH

Authorizing the creation of a State Debt in the amount of \$150,000, the proceeds to be used as a grant to the Board of Directors of the Maryland Sheriffs' Youth Ranch, Inc. for the acquisition, planning, design, construction, repair, renovation, reconstruction, site improvement, and capital equipping of The Ranch, located in Frederick County; providing for disbursement of the loan proceeds; etc.

SENATE BILLS REASSIGNED February 28, 2018**SB 1145 Senator Serafini****COUNTY BOARDS OF EDUCATION – LEASING OF SCHOOL PROPERTY**

Authorizing certain exceptions to the requirement that certain public school property must be held in trust by a county board of education; authorizing a county or a county board to lease certain property; and excluding certain lease payments made by a county board of education from the maintenance of effort calculation.

SB 1148 Washington County Senators**WASHINGTON COUNTY – ADVISORY SCHOOL DESIGN REVIEW COMMITTEE – REPEAL**

Repealing a provision of law requiring the Washington County Commissioners to establish an Advisory School Design Review Committee; repealing provisions establishing the Committee's duties and relating to the review of the Committee's comments and recommendations; repealing a provision requiring the Washington County Board of Education to provide a certain schedule of project milestones to the Committee; and making the Act an emergency measure.
