SENATE BILLS INTRODUCED March 5, 2018

SB 1236 Chair, PSTE Subcommittee, Budget and Taxation Comm

PUBLIC-PRIVATE PARTNERSHIPS – TRANSPORTATION FACILITY PROJECTS – ENVIRONMENTAL IMPACT STATEMENT

Requiring the reporting agency for certain transportation facility projects to submit a draft environmental impact statement that complies with the National Environmental Policy Act to the Comptroller, the State Treasurer, the budget committees, and the Department of Legislative Services at least 45 days before requesting that the Board of Public Works designate a public—private partnership; etc.

NATURAL RESOURCES – PUBLIC SHELLFISH FISHERY AREA – STANDARDS

Requiring the Department of Natural Resources to establish areas in the Chesapeake Bay as part of the public shellfish fishery area if the areas have an oyster density, as determined by a biological survey, of at least one oyster per square meter; and requiring the Department to establish natural oyster bars as part of the public shellfish fishery area that have been planted with oyster shell, planted with spat, or where the density of oysters is at least one oyster per square meter.

FAMILY LAW - GRANDPARENT VISITATION

Altering the circumstances under which an equity court may grant visitation rights to a grandparent of a child; and authorizing the court to consider parental consent or, if consent is not present, to determine whether visitation rights are in the best interest of the child and do not interfere with the parent—child relationship.

APPOINTMENT OR DESIGNATION OF STANDBY GUARDIAN – IMMIGRATION ACTION AGAINST A PARENT

Making certain provisions relating to the appointment or designation of a standby guardian of the person or property of a minor in cases of incapacity, debilitation, or death of a parent applicable to the appointment or designation of a standby guardian of the person or property of a minor in the case of detainment by immigration officials, voluntary departure in lieu of removal under certain federal law, or removal from the United States of a parent; etc.

GENERAL PROVISIONS – COMMEMORATIVE DAYS AND MONTHS – POST–TRAUMATIC STRESS INJURY AWARENESS

Requiring the Governor to proclaim annually June 27 as Post—Traumatic Stress Injury Awareness Day; and requiring the Governor to proclaim annually the month of June as Post—Traumatic Stress Injury Awareness Month.

BALTIMORE CITY – INDEPENDENT INSTITUTIONS OF HIGHER EDUCATION – POLICE FORCE

Authorizing an independent institution of higher education in Baltimore City to establish a campus police force based on a certain memorandum of understanding; authorizing a police officer of a campus police force of an independent institution of higher education in Baltimore City to exercise the powers granted to a peace and police officer only on certain property with certain exceptions; etc.

BURIAL SITES – ACCESS, DISINTERMENT, CRIMINAL PENALTIES, AND TAX CREDIT

Requiring a person who brings a certain action for sale of a burial ground to conduct a certain genealogical and historical search; authorizing a court to reject the sale of a burial ground under certain circumstances; prohibiting a person from desecrating human remains; requiring that the owner of a burial site that is more than 50 years old and in which the majority of persons interred have been interred for more than 50 years consult with the Maryland Historical Trust regarding certain matters; etc.

21ST CENTURY SCHOOL FACILITIES ACT

Altering the requirements for awarding contracts to bidders for school buildings; requiring the Interagency Committee on School Construction to conduct a certain facility assessment; specifying the process for the review and approval of public school construction projects; establishing the Local Share of School Construction Costs Revolving Loan Fund; declaring the intent of the General Assembly regarding funding for public school construction; etc.

MOTOR VEHICLES - VIDEO TOLL VIOLATION - HEARING VENUE

Authorizing a hearing on a certain video toll violation to be held in the county in which the offense allegedly was committed or the county in which the person charged with the violation resides, if the person is a resident of the State.

CREATION OF A STATE DEBT – PRINCE GEORGE'S COUNTY – MOUNT RAINIER CIVIC CENTER

Authorizing the creation of a State Debt not to exceed \$300,000, the proceeds to be used as a grant to the Mayor and City Council of the City of Mount Rainier for the acquisition, planning, design, construction, repair, renovation, reconstruction, site improvement, and capital equipping of the Mount Rainier Civic Center, located in Prince George's County; providing for disbursement of the loan proceeds, subject to a requirement that the grantee provide and expend a matching fund; etc.

CRIMINAL PROCEDURE - PARTIAL EXPUNGEMENT

Authorizing a person to file a petition for a partial expungement of certain criminal records under certain circumstances; requiring a court to order that certain records be removed from a certain website; providing that only a certain record is eligible for partial expungement; repealing a provision of law establishing that if a person is not entitled to expungement of one charge or conviction in a certain unit, the person is not entitled to expungement of any other charge or conviction in the unit; etc.

CREATION OF A STATE DEBT – PRINCE GEORGE'S COUNTY – ST. THOMAS METHODIST CHURCH RESTORATION

Authorizing the creation of a State Debt in the amount of \$25,000, the proceeds to be used as a grant to the Board of Trustees of Christ United Methodist Church for the acquisition, planning, design, construction, repair, renovation, reconstruction, site improvement, and capital equipping of St. Thomas Methodist Church, located in Prince George's County; providing for disbursement of the loan proceeds; prohibiting the use of the loan proceeds for sectarian religious purposes; etc.

SMALL, MINORITY, AND WOMEN–OWNED BUSINESSES ACCOUNT – FUNDING

Requiring that 1.5% of the proceeds of video lottery terminals at certain video lottery facilities be paid to the Small, Minority, and Women–Owned Businesses Account; etc.

PRINCE GEORGE'S COUNTY – SCHOOL FACILITIES AND PUBLIC SAFETY SURCHARGES – MARYLAND TRANSIT ADMINISTRATION STATION

Providing for a certain reduction in the school facilities surcharge in Prince George's County for certain residential housing that is constructed within a certain distance of a MARC station or a Purple Line station; providing for an exemption from the school facilities surcharge for certain dwelling units that are constructed within a certain distance of a MARC station or a Purple Line station; etc.

CRIMINAL LAW – THREAT OF MASS VIOLENCE AND DEADLY WEAPONS ON PUBLIC SCHOOL PROPERTY

Altering a certain prohibition relating to threatening to commit a certain crime of violence so as to prohibit a person from knowingly threatening to commit or threatening to cause to be committed a certain crime of violence that would place five or more minors at substantial risk of death or serious physical injury if the threat were carried out; altering and establishing certain penalties; etc.

PROPERTY TAX – MUNICIPAL CORPORATIONS – ELECTRICITY GENERATION FACILITIES – NEGOTIATED PAYMENTS IN LIEU OF TAXES

Authorizing a municipal corporation to enter into an agreement with the owner of an electricity generation facility that is located or locates in the municipal corporation for a negotiated payment by the owner of the facility in lieu of taxes on the facility; requiring a certain agreement between a municipal corporation and a certain electricity generation facility to provide for certain matters; etc.

PROGRAM OPEN SPACE – DEFINITION OF LOCAL GOVERNING BODY – ALTERATION

Altering the definition of "local governing body" as it relates to Program Open Space to include the Maryland–National Capital Park and Planning Commission only in Montgomery County.
