in line 15, strike "(2)" and substitute "<u>(3)</u>"; in line 17, strike "THE TRAILING 12– MONTH AVERAGE OF"; in the same line, after "COMPANY'S" insert "<u>ALL–IN</u>"; and in line 24, strike "(3)" and substitute "<u>(4)</u>".

On page 16 of the Education, Energy, and the Environment Committee Amendments (SB0001/113029/01), in line 13 of Amendment No. 2, strike "(2)(V)" and substitute "(3)(V)"; and in line 14, strike "(4)" and substitute "(5)".

On page 18 of the bill, in line 1, strike "(**3**)" and substitute "<u>(**4**)</u>"; and after line 12, insert:
