AMENDMENTS TO HOUSE BILL 333

(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in the sponsor line, strike "and Wilkins" and substitute ".Wilkins, Wims, Vogel, Wu, Atterbeary, Ebersole, and Young"; in line 2, strike "on Large Social Media Platforms"; in the same line, after "and" insert "Improper"; strike beginning with "each" in line 4 down through "disinformation" in line 12 and substitute "the State Board of Elections to maintain a portal on the State Board's website that the public may use to report election disinformation; requiring the State Board to conduct a periodic review of material submitted by the public through the portal and, to the extent necessary, issue corrective information or refer submissions to the State Prosecutor"; in line 12, strike "a"; in the same line, strike "provision" and substitute "provisions"; in line 13, strike "related to offenses" and substitute "prohibiting improper influence"; in line 14, strike "on large social media platforms" and substitute "and improper influence related to voting"; in line 17, strike "13–405.3" and substitute "2–110"; and strike in their entirety lines 20 through 24, inclusive.

AMENDMENT NO. 2

On page 2, in line 5, strike "13–405.3." and substitute "2–110."; in line 6, strike "(1)"; and strike beginning with "SECTION" in line 6 down through "PROCEDURES," in line 9 and substitute "SECTION, "ELECTION DISINFORMATION" MEANS INCORRECT OR MISLEADING INFORMATION REGARDING THE TIME, PLACE, OR MANNER OF AN ELECTION,".

On pages 2 through 4, strike in their entirety the lines beginning with line 11 on page 2 through line 10 on page 4, inclusive, and substitute:

- "(B) (1) THE STATE BOARD SHALL MAINTAIN A PORTAL ON THE STATE BOARD'S WEBSITE THAT THE PUBLIC MAY USE TO REPORT ELECTION DISINFORMATION.
- (2) THE STATE BOARD SHALL CONDUCT A PERIODIC REVIEW OF MATERIAL SUBMITTED BY THE PUBLIC THROUGH THE PORTAL AND, TO THE EXTENT NECESSARY, ISSUE CORRECTIVE INFORMATION OR REFER SUBMISSIONS TO THE STATE PROSECUTOR.".

On pages 4 and 5, strike in their entirety the lines beginning with line 11 on page 4 through line 30 on page 5, inclusive.

On page 6, in line 1, strike "(1)"; in line 3, after "ANOTHER" insert ", REGARDLESS OF THE MEDIUM USED"; and strike in their entirety lines 4 through 7, inclusive.
