3 FOR the purpose of authorizing certain health occupations boards to adopt regulations
4 establishing reciprocity for individuals licensed or certified in another state ~~or~~
5 ~~jurisdiction~~; and generally relating to health occupations boards and reciprocal
6 licensure and certification.

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
13 That the Laws of Maryland read as follows:

14 **Article – Health Occupations**

15 **1–229.**

16 **(A) THIS SECTION APPLIES ONLY TO A HEALTH OCCUPATIONS BOARD THAT**
17 **DOES NOT OTHERWISE HAVE STATUTORY AUTHORITY TO ISSUE LICENSES OR**
18 **CERTIFICATIONS UNDER THIS ARTICLE BY RECIPROCITY.**

EXPLANATION: CAPITALS INDICATE MATTER ADDED TO EXISTING LAW.

[Brackets] indicate matter deleted from existing law.

Underlining indicates amendments to bill.

~~Strike out~~ indicates matter stricken from the bill by amendment or deleted from the law by amendment.



1 **(B) SUBJECT TO SUBSECTION (C) OF THIS SECTION, A HEALTH**
 2 **OCCUPATIONS BOARD MAY ADOPT REGULATIONS TO ESTABLISH RECIPROCITY FOR**
 3 **INDIVIDUALS WHO ARE LICENSED OR CERTIFIED IN ANOTHER STATE ~~OR~~**
 4 **~~JURISDICTION~~ THAT OFFERS SIMILAR RECIPROCITY TO INDIVIDUALS LICENSED OR**
 5 **CERTIFIED BY THE HEALTH OCCUPATIONS BOARD UNDER THIS ARTICLE.**

6 **(C) REGULATIONS ADOPTED BY A HEALTH OCCUPATIONS BOARD UNDER**
 7 **SUBSECTION (B) OF THIS SECTION SHALL REQUIRE THAT AN APPLICANT:**

8 **(1) BE LICENSED OR CERTIFIED IN ANOTHER STATE ~~OR~~**
 9 **~~JURISDICTION~~ UNDER REQUIREMENTS THAT THE HEALTH OCCUPATIONS BOARD**
 10 **DETERMINES ARE SUBSTANTIALLY EQUIVALENT TO ITS LICENSING OR**
 11 **CERTIFICATION REQUIREMENTS ESTABLISHED UNDER THIS ARTICLE;**

12 **(2) BE IN GOOD STANDING UNDER THE LAWS OF THE OTHER STATE**
 13 **~~OR JURISDICTION;~~**

14 **(3) SUBMIT AN APPLICATION TO THE HEALTH OCCUPATIONS BOARD**
 15 **ON A FORM THAT THE BOARD REQUIRES;**

16 **(4) PAY TO THE HEALTH OCCUPATIONS BOARD AN APPLICATION FEE**
 17 **SET BY THE BOARD; AND**

18 **(5) SATISFY ANY OTHER REQUIREMENTS ESTABLISHED BY STATUTE**
 19 **OR REGULATIONS ADOPTED BY THE HEALTH OCCUPATIONS BOARD.**

20 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
 21 1, 2024.
