AN ACT concerning
Motor Vehicle Administration <u>and Local Health Departments</u> – Death Certificates – Issuance of Copies
FOR the purpose of authorizing the Motor Vehicle Administration <u>and local health departments</u> to access electronically from the Maryland Department of Health a copy of a death certificate and, on request, provide any person authorized by regulations with a certified or abridged copy of a death certificate; authorizing the Administration <u>and local health departments</u> to set and collect a fee for processing and issuing death certificates, subject to certain limitations; and generally relating to the issuance of copies of death certificates.
BY repealing and reenacting, with amendments, Article – Health – General Section 4–217(a), (c), and (d)

3 4	SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

7 8 9 10	(a) (1) Except as provided in subsection (b) of this section, the Secretary shall provide, on request, any person authorized by regulations adopted under this subtitle with a certified or abridged copy of a birth, death, or fetal death certificate registered under this subtitle or of the certificate of a marriage performed after June 1, 1951.
11 12 13	(2) Except as provided in subsection (b) of this section and subject to subsection (h) of this section, a local health department or the Motor Vehicle Administration may:
14 15	(i) Access electronically from the Department a certified or abridged copy of a birth certificate OR DEATH CERTIFICATE registered under this subtitle; and
16 17 18	(ii) On request, provide any person authorized by regulations adopted under this subtitle with a certified or abridged copy of a birth certificate OR DEATH CERTIFICATE registered under this subtitle.
19 20	(3) (i) The Secretary shall provide on request, to any person authorized by regulation adopted under this subtitle, a commemorative birth certificate.

2 3 4 5 6	(ii) The fee set by the local health department or the Motor Vehicle Administration for processing and issuing a birth certificate or for a report under subparagraph (i) of this paragraph may not exceed the actual costs to the local health department or the Motor Vehicle Administration for processing and issuing a birth certificate <i>OR DEATH CERTIFICATE</i> or a report.
7 8 9	(iii) From the fee the local health department or the Motor Vehicle Administration collects under subparagraph (i) of this paragraph, \$10 shall be transferred to the General Fund.
10 11 12 13 14	(iv) Prior to setting and collecting a fee for processing and issuing a birth certificate <u>OR DEATH CERTIFICATE</u> or for a report under subparagraph (i) of this paragraph, the local health department or the Motor Vehicle Administration shall enter into a memorandum of understanding with the Maryland Department of Health that outlines the local health department's or the Motor Vehicle Administration's fee structure.

22 23	1. A current or former member of the armed forces of the United States; or

26 27 28	(ii) 1. In this subparagraph, "homeless individual" has the meaning stated in the federal McKinney-Vento Homeless Education Assistance Improvements Act of 2001 [(42 U.S.C. § 11302(a))].
29 30 31	2. Subject to subsubparagraph 4 of this subparagraph, the Department may not collect a fee for a certified or an abridged copy of a birth certificate issued to a homeless individual.
32	3. The Department shall accept as proof of homelessness a

signed written statement from a homeless services provider located in the State that:

1	A. Affirms that the individual is homeless; and
2 3	B. Includes the address to which the copy of the birth certificate requested under this section may be sent.
