3 FOR the purpose of ~~establishing the Waterway Incident Notification System (WINS)~~
4 ~~Workgroup~~ requiring the Maryland Department of Emergency Management to study
5 issues and factors regarding the feasibility of establishing a Waterway Incident
6 Notification System (WINS) to notify members of the public of certain waterway
7 emergencies; and generally relating to a study on the Waterway Incident
8 Notification System (WINS) ~~Workgroup~~.

9 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
10 That:

11 (a) ~~There is a Waterway Incident Notification System (WINS) Workgroup.~~

12 (b) ~~The Workgroup consists of the following members:~~

13 (1) ~~one member of the Senate of Maryland, appointed by the President of~~
14 ~~the Senate;~~

15 (2) ~~one member of the House of Delegates, appointed by the Speaker of the~~
16 ~~House;~~

17 (3) ~~the Secretary of Emergency Management, or the Secretary's designee;~~

20 ~~(e) The Maryland Department of Emergency Management shall provide staff for~~

22 ~~(f) A member of the Workgroup:~~

23 ~~(1) may not receive compensation as a member of the Workgroup; but~~

24 ~~(2) is entitled to reimbursement for expenses under the Standard State~~
25 ~~Travel Regulations, as provided in the State budget.~~

26 (a) In this section, "Department" means the Maryland Department of Emergency
27 Management.

28 ~~(g)~~ (b) The Workgroup Department, in consultation with other interested
29 stakeholders, shall study and make recommendations regarding:

30 (1) the feasibility of establishing a Waterway Incident Notification System
31 (WINS) to notify members of the public, including recreational boaters and commercial

1 watermen, of active waterway emergencies involving a person at risk of death or serious
2 bodily harm, emergency marine events, or marine hazards; and

3 (2) potential partnerships among the State, the U.S. Coast Guard, the U.S.
4 Navy, and nearby states to improve notifications to members of the public, including
5 recreational boaters and commercial watermen, of waterway emergencies involving a
6 person at risk of death or serious bodily harm, emergency marine events, or marine
7 hazards.

8 ~~(b)~~ (c) (1) On or before December ~~31~~ 1, 2024, the ~~Workgroup~~ Department shall
9 submit an interim report of its findings and recommendations to the Governor and, in
10 accordance with § 2-1257 of the State Government Article, the General Assembly.

11 (2) On or before ~~September 30~~ December 1, 2025, the ~~Workgroup~~
12 Department shall submit a final report of its findings and recommendations to the
13 Governor and, in accordance with § 2-1257 of the State Government Article, the General
14 Assembly.

15 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect June
16 1, 2024. It shall remain effective for a period of 2 years and 1 month and, at the end of June
17 30, 2026, this Act, with no further action required by the General Assembly, shall be
18 abrogated and of no further force and effect.
