## CHAPTER \_\_\_\_\_

1 AN ACT concerning

2 **General Assembly Vacancy – Political Party Central Committees – Procedures**

3 FOR the purpose of establishing requirements for the filling of a vacancy in the office of  
4 Senator or Delegate in the General Assembly by a central committee of a political  
5 party under the Maryland Constitution relating to applications, public notice, public  
6 meetings, and voting; and generally relating to the procedures of a central committee  
7 of a political party for filling a vacancy in the General Assembly.

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
14 That the Laws of Maryland read as follows:

15 **Article – Election Law**

16 **4–206.**

17 **(A) THIS SECTION APPLIES ONLY TO THE PROCESS OF FILLING A VACANCY**  
18 **IN THE OFFICE OF SENATOR OR DELEGATE IN THE GENERAL ASSEMBLY UNDER**  
19 **ARTICLE III, § 13 OF THE MARYLAND CONSTITUTION.**

1           **(B) (1) THE APPLICATION PERIOD TO APPLY TO A CENTRAL COMMITTEE**  
2 **TO FILL A VACANCY SHALL BE:**

3                   **(I) OPEN FOR AT LEAST 7 DAYS; AND**

4                   **(II) ADVERTISED IN A CONSPICUOUS MANNER BY THE CENTRAL**  
5 **COMMITTEE FILLING THE VACANCY BY A PUBLIC NOTICE THAT INCLUDES:**

6                   1.     **THE CENTRAL COMMITTEE'S INTENT TO MEET TO FILL**  
7 **THE VACANCY;**

8                   2.     **THE TIME AND PLACE OF ANY MEETINGS TO BE HELD**  
9 **TO DISCUSS OR VOTE ON THE FILLING OF THE VACANCY;**

10                  3.     **THE PROCESS FOR FILLING THE VACANCY; AND**

11                  4.     **THE MANNER IN WHICH INDIVIDUALS MAY APPLY TO**  
12 **FILL THE VACANCY.**

13                   **(2) THE NOTICE REQUIRED UNDER PARAGRAPH (1)(II) OF THIS**  
14 **SUBSECTION SHALL BE TRANSLATED INTO A LANGUAGE OTHER THAN ENGLISH IF**  
15 **THE LOCAL BOARD FOR THE COUNTY IN WHICH THE CENTRAL COMMITTEE IS**  
16 **LOCATED IS REQUIRED TO TRANSLATE ELECTION MATERIALS INTO THAT LANGUAGE**  
17 **UNDER § 203 OF THE FEDERAL VOTING RIGHTS ACT.**

18           **(C) ALL APPLICATIONS SUBMITTED TO A CENTRAL COMMITTEE TO FILL A**  
19 **VACANCY SHALL:**

20                   **(1) BE POSTED ONLINE PROMPTLY AFTER THE APPLICATION**  
21 **DEADLINE BY THE COUNTY CENTRAL COMMITTEE OR THE STATE CENTRAL**  
22 **COMMITTEE OF THE POLITICAL PARTY; AND**

23                   **(2) REMAIN POSTED ONLINE UNTIL AT LEAST 30 DAYS AFTER THE**  
24 **CENTRAL COMMITTEE VOTES ON AN INDIVIDUAL TO FILL THE VACANCY.**

25           **(D) THE CENTRAL COMMITTEE SHALL HOLD A PUBLIC MEETING TO**  
26 **INTERVIEW THE INDIVIDUALS WHO APPLIED TO FILL THE VACANCY.**

27           **(E) A MEETING HELD BY A CENTRAL COMMITTEE TO DISCUSS OR VOTE ON**  
28 **FILLING A VACANCY SHALL BE:**

29                   **(1) OPEN TO THE PUBLIC; AND**

30                   **(2) ANNOUNCED AT LEAST 3 DAYS BEFORE THE MEETING.**

1 (F) (1) THE VOTE BY A CENTRAL COMMITTEE TO CHOOSE AN INDIVIDUAL  
2 TO FILL A VACANCY SHALL BE:

3 (I) BY ROLL CALL VOTE OR BY SIGNED BALLOTS; AND

4 (II) IN A MEETING OPEN TO THE PUBLIC.

5 (2) A MEMBER OF THE CENTRAL COMMITTEE WHO HAS APPLIED TO  
6 FILL THE VACANCY SHALL RECUSE THEMSELVES FROM:

7 (I) ADMINISTERING THE PROCESS OF FILLING THE VACANCY,  
8 INCLUDING ADVERTISING THE VACANCY, REVIEWING APPLICATIONS, AND  
9 INTERVIEWING CANDIDATES; AND

10 (II) VOTING ON THE INDIVIDUAL TO FILL THE VACANCY.

11 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
12 October 1, 2024.
