A BILL ENTITLED

1 AN ACT concerning

2 **Economic Development – Entrepreneurial Innovation Programs –**
3 **Establishment**
4 **(Pava LaPere Legacy of Innovation Act of 2024)**

5 FOR the purpose of establishing the Pava LaPere Innovation Acceleration Grant Program
6 in the Maryland Technology Development Corporation to provide grants to certain
7 technology-based start-up companies; establishing the Baltimore Innovation
8 Initiative Pilot Program within the Maryland Innovation Initiative of the
9 Corporation; requiring certain appropriations for the programs to be included in the
10 annual budget bill in certain fiscal years; repealing a mandated appropriation for a
11 certain telework assistance grant program; and generally relating to development of
12 entrepreneurial innovation programs.

11 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
12 That the Laws of Maryland read as follows:

13 **Article – Economic Development**

14 **5–1702.**

15 (a) There is a Business Telework Assistance Grant Program in the Department.

16 [(f) For each fiscal year, the Governor shall include in the annual budget bill an
17 appropriation of \$1,000,000 for the Program.]

18 [(g)] (F) The Secretary shall adopt regulations necessary to carry out this
19 section.

20 **10–462.**

21 (A) **THERE IS A PAVA LAPERE INNOVATION ACCELERATION GRANT
22 PROGRAM IN THE CORPORATION.**

23 (B) **THE CORPORATION SHALL ADMINISTER THE PROGRAM.**

24 (C) **THE PURPOSE OF THE PROGRAM IS TO FOSTER GROWTH OF THE
25 ENTREPRENEURIAL INNOVATION ECOSYSTEM IN THE STATE BY PROVIDING GRANTS
26 TO TECHNOLOGY–BASED START–UP COMPANIES THAT:**

27 (1) **ARE FOUNDED BY STUDENTS OR FACULTY MEMBERS OF
28 POSTSECONDARY INSTITUTIONS LOCATED IN THE BALTIMORE METROPOLITAN
29 STATISTICAL AREA; AND**

30 (2) **HAVE THEIR PRINCIPAL PLACE OF BUSINESS IN THE BALTIMORE
31 METROPOLITAN STATISTICAL AREA.**

1 (D) AN APPLICANT SHALL SUBMIT AN APPLICATION FOR A PROGRAM
2 AWARD AS REQUIRED BY THE CORPORATION.

3 (E) THE PROGRAM SHALL REVIEW THE APPLICATION AND ALL SUPPORTING
4 MATERIALS TO EVALUATE WHETHER THE APPLICANT QUALIFIES FOR AN AWARD
5 FROM THE PROGRAM.

6 (F) (1) SUBJECT TO PARAGRAPHS (2) AND (3) OF THIS SUBSECTION, THE
7 PROGRAM SHALL AWARD \$50,000 TO EACH QUALIFYING APPLICANT.

8 (2) A QUALIFYING APPLICANT SHALL USE AT LEAST 20% OF THE
9 AWARD TO HIRE THIRD-PARTY CONSULTANTS FOR PLANNING, DEVELOPMENT,
10 REGULATORY COMPLIANCE, OR OTHER TECHNICAL ASSISTANCE RELATED TO
11 ESTABLISHING THE START-UP COMPANY.

12 (3) THE CORPORATION MAY PROVIDE WAIVERS ON REQUEST BY AN
13 APPLICANT.

14 (G) (1) FOR EACH FISCAL YEAR, THE GOVERNOR SHALL INCLUDE AN
15 APPROPRIATION FOR THE PROGRAM IN THE ANNUAL BUDGET BILL.

16 (2) THE PROGRAM MAY USE UP TO 10% OF THE ANNUAL
17 APPROPRIATION FOR ADMINISTRATIVE EXPENSES, NOT TO EXCEED \$50,000 IN A
18 SINGLE FISCAL YEAR.

19 (H) THE CORPORATION SHALL ADOPT REGULATIONS NECESSARY TO CARRY
20 OUT THIS SECTION.

21 SECTION 2. AND BE IT FURTHER ENACTED, That the Laws of Maryland read
22 as follows:

25 (A) (1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE MEANINGS
26 INDICATED.

27 (2) (I) “ELIGIBLE UNIVERSITY” MEANS A PUBLIC OR PRIVATE
28 COLLEGE OR UNIVERSITY LOCATED WITHIN THE BALTIMORE-COLUMBIA-TOWSON
29 AREA.

22 **(3) “PILOT PROGRAM” MEANS THE BALTIMORE INNOVATION**
23 **INITIATIVE PILOT PROGRAM.**

1 **(B) THERE IS A BALTIMORE INNOVATION INITIATIVE PILOT PROGRAM.**

2 **(C) THE PURPOSE OF THE PILOT PROGRAM IS TO PROVIDE INCENTIVES**
3 **FOR AND GROW TECHNOLOGY START-UP COMPANIES FOUNDED BY STUDENTS OR**
4 **FACULTY AT ELIGIBLE UNIVERSITIES.**

5 **(D) THE INITIATIVE SHALL IMPLEMENT AND ADMINISTER THE PILOT**
6 **PROGRAM.**

7 **(E) THE INITIATIVE SHALL COLLABORATE WITH EACH PARTICIPATING**
8 **ELIGIBLE UNIVERSITY TO IDENTIFY AND SUPPORT ENTREPRENEURIAL INITIATIVES,**
9 **INDUSTRY PARTNERSHIPS, AND COMMERCIALIZATION OPPORTUNITIES RELATED**
10 **TO TECHNOLOGY.**

11 **(F) TO QUALIFY FOR PARTICIPATION IN THE PILOT PROGRAM, EACH**
12 **ELIGIBLE UNIVERSITY SHALL PAY AN ANNUAL CONTRIBUTION OF \$50,000.**

13 **(G) (1) ONLY AN ELIGIBLE UNIVERSITY MAY SUBMIT PROJECT**
14 **PROPOSALS FOR FUNDING UNDER THE PILOT PROGRAM.**

15 **(2) TO QUALIFY FOR PARTICIPATION IN THE PILOT PROGRAM, A**
16 **PROJECT PROPOSAL MUST:**

17 **(I) SUPPORT THE CREATION OF A NEW TECHNOLOGY-BASED**
18 **BUSINESS IN THE STATE;**

19 **(II) ADVANCE THE TECHNOLOGY TOWARD**
20 **COMMERCIALIZATION OF A PRODUCT OR SERVICE, WITH PREFERENCE FOR**
21 **PRODUCTS OR SERVICES THAT ALIGN WITH THE GOALS OF INTEGRATING**
22 **ARTIFICIAL INTELLIGENCE OR MACHINE LEARNING IN HEALTH CARE AND**
23 **BIOTECHNOLOGY SECTORS IN THE STATE;**

24 **(III) FOSTER EQUITABLE AND INCLUSIVE ENTREPRENEURIAL**
25 **DEVELOPMENT AT THE ELIGIBLE UNIVERSITY;**

26 **(IV) CREATE AN OPPORTUNITY FOR MEANINGFUL ECONOMIC**
27 **IMPACT IN THE REGION AROUND THE ELIGIBLE UNIVERSITY; OR**

28 **(V) FOSTER COLLABORATION BETWEEN THE ELIGIBLE**
29 **UNIVERSITY AND AN INDUSTRY PARTNER, INCLUDING:**

30 **1. PRODUCT DEVELOPMENT WITH COMMERCIALIZATION**

1 POTENTIAL; AND

2 2. MATCHING FUNDS PROVIDED BY THE INDUSTRY
3 PARTNER.

4 (H) (1) SUBJECT TO PARAGRAPHS (2) AND (3) OF THIS SUBSECTION, THE
5 INITIATIVE SHALL DEVELOP CRITERIA TO REVIEW, EVALUATE, AND RATE PROJECT
6 PROPOSALS FOR FUNDING UNDER THE PILOT PROGRAM.

7 (2) THE EXECUTIVE DIRECTOR OF THE INITIATIVE SHALL
8 DISTRIBUTE GRANTS TO PROJECTS BASED ON THE CRITERIA DEVELOPED IN
9 ACCORDANCE WITH PARAGRAPH (1) OF THIS SUBSECTION.

10 (3) THE INITIATIVE SHALL GIVE PRIORITY TO PROJECT PROPOSALS
11 THAT ALIGN WITH THE MISSION OF THE BALTIMORE TECH HUB OR ARTIFICIAL
12 INTELLIGENCE– AND LIFE SCIENCE–ORIENTED BUSINESSES.

13 (I) (1) FOR FISCAL YEARS 2025 AND 2026, THE GOVERNOR SHALL
14 INCLUDE IN THE ANNUAL BUDGET BILL AN APPROPRIATION OF \$1,500,000 FOR THE
15 PILOT PROGRAM.

16 (2) THE FUNDING PROVIDED IN THIS SUBSECTION SHALL BE USED TO
17 SUPPLEMENT, NOT SUPPLANT, ANY FUNDS THAT WOULD OTHERWISE BE PROVIDED
18 TO THE INITIATIVE.

19 (J) IN ADDITION TO INFORMATION ON THE INITIATIVE INCLUDED IN THE
20 ANNUAL REPORT OF THE CORPORATION UNDER § 10–415 OF THIS SUBTITLE, ON OR
21 BEFORE JULY 1, 2027, THE CORPORATION SHALL REPORT TO THE GENERAL
22 ASSEMBLY, IN ACCORDANCE WITH § 2–1257 OF THE STATE GOVERNMENT ARTICLE,
23 ON THE IMPLEMENTATION OF THE PILOT PROGRAM.

24 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect July
25 1, 2024. Section 2 of this Act shall remain effective for a period of 3 years and, at the end of
26 June 30, 2027, Section 2 of this Act, with no further action required by the General
27 Assembly, shall be abrogated and of no further force and effect.
