1 AN ACT concerning

2 **Families Serve Act of 2024**

3 FOR the purpose of authorizing employers to grant a preference in hiring and promotion to
4 spouses of eligible service members; requiring the appointing authorities in the
5 Executive Branch of State government to apply a certain credit on any selection test
6 for eligible military spouses and veterans of certain uniformed services; and
7 generally relating to hiring and promotion preferences.

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
That the Laws of Maryland read as follows:

Article – Labor and Employment

3–714.

(a) (1) In this section[, “eligible] **THE FOLLOWING WORDS HAVE THE MEANINGS INDICATED.**

(2) **“ELIGIBLE SERVICE MEMBER” MEANS A FULL–TIME ACTIVE DUTY MEMBER OF ~~THE UNIFORMED SERVICES OF~~ ANY BRANCH OF THE ~~ARMED FORCES~~ UNIFORMED SERVICES OF THE UNITED STATES.**

(3) **“ELIGIBLE veteran” means a veteran of any branch of the ~~armed forces~~ UNIFORMED SERVICES of the United States who has received an honorable discharge or a certificate of satisfactory completion of ~~military~~ service, including:**

[(1)] (I) the National Guard;

[(2)] (II) the military reserves;

[(3)] (III) the Commissioned Corps of the Public Health Service; and

[(4)] (IV) the Commissioned Corps of the National Oceanic and Atmospheric Administration.

(b) An employer may grant a preference in hiring and promotion to:

(1) an eligible veteran;

(2) the spouse of an eligible veteran who has a service–connected disability;

[or]

(3) **THE SPOUSE OF AN ELIGIBLE SERVICE MEMBER; OR**

(4) the surviving spouse of a deceased eligible veteran.

(c) Granting a preference under subsection (b) of this section does not violate any State or local equal employment opportunity law.

5 **BRANCH OF THE UNIFORMED SERVICES OF THE UNITED STATES.**

7 **~~forces~~ UNIFORMED SERVICES of the United States who has received an honorable**
8 **discharge or a certificate of satisfactory completion of ~~military~~ service, including the**
9 **National Guard and the military reserves.**

10 (2) (i) An appointing authority shall apply a credit of [ten] **10** points on
11 any selection test for:

12 1. **AN ELIGIBLE MILITARY SPOUSE;**

13 2. an eligible veteran;

14 [2.] 3.the spouse of an eligible veteran who has a service
15 connected disability; or

16 [3.] 4.the surviving spouse of a deceased eligible veteran.

17 (ii) An appointing authority shall apply a credit of two additional
18 points on any selection test for a former prisoner of war.

19 (3) The following applicants are ineligible for a credit under this
20 subsection:

21 (i) a current State employee; and

22 (ii) an eligible veteran who is convicted of a crime after being
23 discharged from or completing military service.

24 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
25 1, 2024.
