31 (1) individually or collectively engage in a pattern of organized crime
 32 activity;

1 (2) have as one of their primary objectives or activities the commission of
2 one or more underlying crimes, including acts by juveniles that would be underlying crimes
3 if committed by adults; and

4 (3) have in common an overt or covert organizational or command
5 structure.

6 (d) “Enterprise” includes:

7 (1) a sole proprietorship, partnership, corporation, business trust, or other
8 legal entity; or

9 (2) any group of individuals associated in fact although not a legal entity.

10 (e) “Pattern of organized crime activity” means the commission of, attempted
11 commission of, conspiracy to commit, or solicitation of two or more underlying crimes or
12 acts by a juvenile that would be an underlying crime if committed by an adult, provided the
13 crimes or acts were not part of the same incident.

14 (f) “Solicit” has the meaning stated in § 11–301 of this article.

15 (g) “Underlying crime” means:

16 (1) a crime of violence as defined under § 14–101 of this article;

18 § 3–1103 (forced marriage), § 4–203 (wearing, carrying, or transporting a handgun), **§**

26 (a) A person may not:

27 (1) participate in a criminal organization knowing that the members of the
 28 criminal organization engage in a pattern of organized crime activity; and

1 (2) knowingly and willfully direct or participate in an underlying crime, or
2 act by a juvenile that would be an underlying crime if committed by an adult, committed
3 for the benefit of, at the direction of, or in association with a criminal organization.

4 (b) A criminal organization or an individual belonging to a criminal organization
5 may not:

6 (1) receive proceeds known to have been derived directly or indirectly from
7 an underlying crime; and

8 (2) use or invest, directly or indirectly, an aggregate of \$10,000 or more of
9 the proceeds from an underlying crime in:

10 (i) the acquisition of a title to, right to, interest in, or equity in real
11 property; or

12 (ii) the establishment or operation of any enterprise.

13 (c) A criminal organization may not acquire or maintain, directly or indirectly,
14 any interest in or control of any enterprise or real property through an underlying crime.

15 (d) A person may not conspire to violate subsection (a), (b), or (c) of this section.

16 (e) A person may not violate subsection (a) of this section that results in the death
17 of a victim.

18 (f) (1) (i) Except as provided in subparagraph (ii) of this paragraph, a
19 person who violates this section is guilty of a felony and on conviction is subject to
20 imprisonment not exceeding 15 years or a fine not exceeding \$1,000,000 or both.

21 (ii) A person who violates subsection (e) of this section is guilty of a
22 felony and on conviction is subject to imprisonment not exceeding 25 years or a fine not
23 exceeding \$5,000,000 or both.

24 (2) (i) A sentence imposed under paragraph (1)(i) of this subsection for
25 a first offense may be separate from and consecutive to or concurrent with a sentence for
26 any crime based on the act establishing a violation of this section.

27 (ii) A sentence imposed under paragraph (1)(i) of this subsection for
28 a second or subsequent offense, or paragraph (1)(ii) of this subsection shall be separate from
29 and consecutive to a sentence for any crime based on the act establishing a violation of this
30 section.

31 (iii) A consecutive sentence for a second or subsequent offense shall
32 not be mandatory unless the State notifies the person in writing of the State's intention to
33 proceed against the person as a second or subsequent offender at least 30 days before trial.

1 (3) In addition to the other penalties provided in this subsection, on
2 conviction the court may:

3 (i) order a person or criminal organization to be divested of any
4 interest in an enterprise or real property;

5 (ii) order the dissolution or reorganization of an enterprise; and

6 (iii) order the suspension or revocation of any license, permit, or prior
7 approval granted to the enterprise or person by a unit of the State or a political subdivision
8 of the State.

9 (g) (1) This subsection applies to a violation of § 5-602, § 5-603, § 5-604(b), §
10 5-606, § 5-612, § 5-613, § 5-614, or § 5-617 of this article.

11 (2) Assets divested under this section and derived from the commission of,
12 attempted commission of, conspiracy to commit, or solicitation of a crime described in
13 paragraph (1) of this subsection, either in whole or in part:

14 (i) if the State investigated and prosecuted a violation described in
15 paragraph (1) of this subsection, shall be deposited in the Addiction Treatment Divestiture
16 Fund established under § 8-6D-01 of the Health – General Article; or

17 (ii) if a local jurisdiction investigated and prosecuted a violation
18 described in paragraph (1) of this subsection, shall be used by the local jurisdiction:

19 1. to support alternatives to incarceration, reentry programs,
20 and addiction treatment services for persons with substance-related disorders;

21 2. to combat criminal organizations through education,
22 training, and resources; or

23 3. to provide assistance to victims of criminal
24 organization-related crimes; and

25 (iii) if more than one jurisdiction participated in an investigation or
26 a prosecution of a violation described in paragraph (1) of this subsection, shall be divided
27 in the manner agreed on by the jurisdictions and used as provided in item (i) or (ii) of this
28 paragraph.

29 (h) A person may be charged with a violation of this section only by indictment,
30 criminal information, or petition alleging a delinquent act.

31 (i) (1) The Attorney General, at the request of the Governor or the State's
32 Attorney for a county in which a violation or an act establishing a violation of this section
33 occurs, may:

1 (i) aid in the investigation of the violation or act; and

2 (ii) prosecute the violation or act.

3 (2) In exercising authority under paragraph (1) of this subsection, the
4 Attorney General has all the powers and duties of a State's Attorney, including the use of
5 the grand jury in the county, to prosecute the violation.
