- 3 (3) "PROGRAM" MEANS THE REPRODUCTIVE HEALTH CARE CLINIC SECURITY GRANT PROGRAM.
- 5 (B) THERE IS A REPRODUCTIVE HEALTH CARE CLINIC SECURITY GRANT 6 PROGRAM IN THE GOVERNOR'S OFFICE OF CRIME PREVENTION, YOUTH, AND 7 VICTIM SERVICES.
