A BILL ENTITLED

1 AN ACT concerning

2 **Motor Vehicles – Allowing Unauthorized Use of a Motor Vehicle and Reckless,**
3 **Negligent, and Aggressive Driving**

4 FOR the purpose of altering the penalties for the offenses of allowing the unauthorized use
5 of a motor vehicle and reckless, negligent, and aggressive driving; adding certain
6 motor vehicle offenses as elements that may contribute to charges for reckless or
7 aggressive driving; and generally relating to motor vehicle offenses.

8 BY repealing and reenacting, with amendments,

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

14 That the Laws of Maryland read as follows:

15 **Article – Transportation**

16 16–305.

17 (a) A person may not knowingly permit a motor vehicle owned by him to be driven
18 on any highway by any person:

19 (1) If the person is not authorized by this title to drive; or

20 (2) Otherwise in violation of any of the provisions of this title.

21 (b) A person may not knowingly permit a motor vehicle under the person’s control
22 to be driven on any highway by any person:

3 (C) **A PERSON CONVICTED OF A VIOLATION OF THIS SECTION IS SUBJECT TO**
4 **A FINE NOT EXCEEDING \$1,000.**

6 (a) A person is guilty of reckless driving if [he] **THE PERSON** drives a motor
7 vehicle:

8 (1) In wanton or willful disregard for the safety of persons or property; [or]

9 (2) In a manner that indicates a wanton or willful disregard for the safety
10 of persons or property; **OR**

11 **(3) AT A SPEED EXCEEDING 90 MILES PER HOUR.**

12 (b) A person is guilty of negligent driving if [he] **THE PERSON** drives a motor
13 vehicle in a careless or imprudent manner that endangers any property or the life or person
14 of any individual.

15 (c) **(1)** A person convicted of a violation of subsection (a) of this section is
16 subject to **IMPRISONMENT NOT EXCEEDING 1 YEAR OR** a fine not exceeding **[\$1,000]**
17 **\$5,000 OR BOTH.**

18 **(2) A PERSON CONVICTED OF A VIOLATION OF SUBSECTION (B) OF**
19 **THIS SECTION IS SUBJECT TO IMPRISONMENT NOT EXCEEDING 2 MONTHS OR A FINE**
20 **NOT EXCEEDING \$3,000 OR BOTH.**

22 **(A)** A person is guilty of aggressive driving if the person commits three or more of
23 the following offenses at the same time or during a single and continuous period of driving
24 in violation of:

25 (1) **§ 21-201 OF THIS TITLE (FAILURE TO OBEY TRAFFIC CONTROL**
26 **DEVICE OR LEAVING ROADWAY TO AVOID TRAFFIC CONTROL DEVICE);**

27 **(2)** § 21-202 of this title (Traffic lights with steady indication);

28 **[(2)] (3)** § 21-303 of this title (Overtaking and passing vehicles);

29 **[(3)] (4)** § 21-304 of this title (Passing on right);

1 **(5) § 21-305 OF THIS TITLE (DRIVING LEFT OF CENTER OF ROADWAY**
2 **IN OVERTAKING AND PASSING VEHICLE);**

3 **(6) § 21-307 OF THIS TITLE (DRIVING ON LEFT IN NO-PASSING ZONE);**

15 posted maximum speed limit);

16 **(15) § 21-1117 OF THIS TITLE (SKIDDING, SPINNING WHEELS, AND**

18 **(16) § 21-1131 OF THIS TITLE (DISCHARGING DIESEL EMISSIONS ONTO**
19 **ANOTHER);**

20 **(17) § 21-1209(A) OF THIS TITLE (AVOIDING COLLISION AND**
21 **OVERTAKING AND PASSING BICYCLE, EPAMD, OR MOTOR SCOOTER);**

22 **(18) § 21-1303(C) OF THIS TITLE (MOTORCYCLE OVERTAKING AND**
23 **PASSING IN SAME LANE AS ANOTHER VEHICLE); OR**

24 **(19) § 21-1303(D) OF THIS TITLE (MOTORCYCLE OPERATING**
25 **BETWEEN LANES OF TRAFFIC OR VEHICLES).**

26 **(B) A PERSON IS GUILTY OF AGGRESSIVE DRIVING IF THE PERSON COMMITS**
27 **TWO OR MORE OF THE OFFENSES ENUMERATED IN SUBSECTION (A) OF THIS**
28 **SECTION AT THE SAME TIME OR DURING A SINGLE AND CONTINUOUS PERIOD OF**

1 **DRIVING IN A HIGHWAY WORK ZONE, AS DEFINED IN § 21-802.1 OF THIS TITLE, OR A**
2 **SCHOOL ZONE, AS DEFINED IN § 21-809 OF THIS TITLE.**

3 **(C) A PERSON CHARGED WITH A FIRST OFFENSE FOR A VIOLATION OF THIS**
4 **SECTION:**

5 **(1) MUST APPEAR IN COURT; AND**

6 **(2) MAY NOT PREPAY THE FINE.**

7 **(D) A PERSON CONVICTED OF A VIOLATION OF THIS SECTION IS SUBJECT**
8 **TO:**

9 **(1) FOR A FIRST OFFENSE, A FINE NOT EXCEEDING \$1,000;**

10 **(2) FOR A SECOND OFFENSE, IMPRISONMENT NOT EXCEEDING 2**
11 **MONTHS OR A FINE NOT EXCEEDING \$2,000 OR BOTH; AND**

12 **(3) FOR A THIRD OR SUBSEQUENT OFFENSE, IMPRISONMENT NOT**
13 **EXCEEDING 1 YEAR OR A FINE NOT EXCEEDING \$3,000 OR BOTH.**

14 **SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect**
15 **October 1, 2024.**
