## CHAPTER \_\_\_\_\_

1 AN ACT concerning

2 **Baltimore County – Sheriff – Salary**

3 FOR the purpose of altering the annual salary of the Sheriff of Baltimore County; and  
4 generally relating to the salary of the Sheriff of Baltimore County.

5 BY repealing and reenacting, without amendments,  
6 Article – Courts and Judicial Proceedings

10 BY repealing and reenacting, with amendments,

15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
16 That the Laws of Maryland read as follows:

17 **Article – Courts and Judicial Proceedings**

18 2–317.

19 (a) This section applies only in Baltimore County.

1 (b) The Sheriff of Baltimore County shall receive an annual salary [of]:

2 (1) **OF \$90,000 FOR CALENDAR YEARS 2024 AND 2025;**

3 (2) **[\$75,000] OF \$138,000** for calendar year [2007] **2026;**

4 [(2)] (3) **[\$80,000] OF \$143,000** for calendar year [2008] **2027;**

5 [(3)] (4) **[\$85,000] OF \$150,000** for calendar year [2009] **2028;** [and]

6 [(4)] (5) **[\$90,000] OF \$157,500** for calendar year [2010] **2029;** and

7 (6) **SUBJECT TO § 35 OF ARTICLE III OF THE MARYLAND**  
 8 **CONSTITUTION, AS THE COUNTY COUNCIL OF BALTIMORE COUNTY PROVIDES IN**  
 9 **ITS ANNUAL BUDGET** each subsequent calendar year.

10 SECTION 2. AND BE IT FURTHER ENACTED, That, in accordance with Article  
 11 III, § 35 of the Maryland Constitution, this Act may not be construed to extend or apply to  
 12 the salary or compensation of the Sheriff of Baltimore County while serving in a term of  
 13 office beginning before the effective date of this Act, but the provisions of this Act  
 14 concerning the salary or compensation of the Sheriff of Baltimore County shall take effect  
 15 at the beginning of the next following term of office. This limitation does not apply to an  
 16 individual appointed or elected after the effective date of this Act to fill out an unexpired  
 17 term.

18 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect  
 19 October 1, 2024.
