CHAPTER _____

1 AN ACT concerning

2 **Baltimore City – Alcoholic Beverages – B–D–7 Licenses – Hours of Sale**

3 FOR the purpose of altering a geographic boundary in the 45th alcoholic beverages district
4 of Baltimore City within which the holder of a B–D–7 beer, wine, and liquor license
5 must operate in accordance with specified hours; and generally relating to alcoholic
6 beverages in Baltimore City.

17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
18 That the Laws of Maryland read as follows:

19 **Article – Alcoholic Beverages and Cannabis**

4 (c) A holder of a Class B-D-7 beer, wine, and liquor license may sell beer, wine,
5 and liquor:

6 (1) from 9 a.m. to 9 p.m. in the area bounded by Liberty Heights Avenue,
7 Northern Parkway, Druid Park Drive, and Wabash Avenue;

8 (2) from 9 a.m. to 9 p.m. along the south side of Frederick Avenue between
9 South Augusta Avenue and South Loudon Avenue;

10 (3) from 9 a.m. to 10 p.m. in the area specified in the Park Heights Master
11 Plan adopted by the City in 2006; and

12 (4) from 9 a.m. to 10 p.m. in an area bounded [on the north by North
13 Avenue, on the west by Central Avenue and Harford Avenue, on the south by Monument
14 Street as it runs from North Central Avenue to North Wolfe Street and McElderry Street
15 as it runs from North Wolfe Street to Luzerne Avenue, and on the east by Luzerne Avenue
16 as it runs from Monument Street to Federal Street, then by Rose Street as it runs from
17 Federal Street to North Avenue] **AS FOLLOWS: FROM THE INTERSECTION OF EAST
18 NORTH AVENUE AND HARFORD AVENUE, SOUTHWEST ON HARFORD AVENUE TO
19 THE INTERSECTION OF HARFORD AVENUE AND NORTH CENTRAL AVENUE, SOUTH
20 ON NORTH CENTRAL AVENUE TO THE INTERSECTION WITH EAST MONUMENT
21 STREET, EAST ON EAST MONUMENT STREET TO THE INTERSECTION OF EAST
22 MONUMENT STREET AND NORTH WOLFE STREET, SOUTH ON NORTH WOLFE
23 STREET TO THE INTERSECTION OF NORTH WOLFE STREET AND MCELDERRY

1 ON EAST NORTH AVENUE TO THE INTERSECTION OF EAST NORTH AVENUE AND
 2 HARFORD AVENUE; and

3 (5) from 6 a.m. to 2 a.m. the following day in all other locations in the City.

5 (c) (1) This subsection does not apply to:

6 (i) a Class B beer and light wine license;

7 (ii) a Class B beer, wine, and liquor license;

8 (iii) a Class B–D–7 beer, wine, and liquor license;

9 (iv) a Class C beer and light wine license; and

10 (v) a Class C beer, wine, and liquor license.

11 (2) For a license holder in an area bounded by Liberty Heights Avenue,
 12 Northern Parkway, Druid Park Drive, and Wabash Avenue, the hours of sale:

13 (i) may not begin before 9 a.m. or end after 10 p.m.; and

14 (ii) may not be extended if they begin later than 9 a.m. or end before
 15 10 p.m.

16 (3) For a license holder in an area bounded [on the north by North Avenue,
 17 on the west by Central Avenue and Harford Avenue, on the south by Monument Street as
 18 it runs from North Central Avenue to North Wolfe Street and McElderry Street as it runs
 19 from North Wolfe Street to Luzerne Avenue, and on the east by Luzerne Avenue as it runs
 20 from Monument Street to Federal Street, then by Rose Street as it runs from Federal Street
 21 to North Avenue] **AS FOLLOWS: FROM THE INTERSECTION OF EAST NORTH AVENUE
 22 AND HARFORD AVENUE, SOUTHWEST ON HARFORD AVENUE TO THE INTERSECTION
 23 OF HARFORD AVENUE AND NORTH CENTRAL AVENUE, SOUTH ON NORTH CENTRAL
 24 AVENUE TO THE INTERSECTION WITH EAST MONUMENT STREET, EAST ON EAST

- 10 (i) may not begin before 9 a.m. or end after 10 p.m.; and
- 11 (ii) may not be extended if they begin later than 9 a.m. or end before
 12 10 p.m.

13 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect June
 14 1, 2024.
