2 **Transportation – Major Change in Bus Service – ~~Impacts Report~~ Publication on**

4 FOR the purpose of ~~requiring the Maryland Transit Administration, before announcing any~~  
5 ~~reduction or cancellation of an existing bus route or line, to compile a report on the~~  
6 ~~impacts of the proposed service reduction or cancellation; requiring the~~  
7 ~~Administration to publish the report on its website at least a certain number of days~~  
8 ~~before the required public hearing on the proposed service change altering the~~  
9 ~~information that the Maryland Transit Administration is required to publish on its~~  
10 ~~website before holding a public hearing on a major service change; requiring the~~  
11 ~~Administration to distribute the report a certain report on proposed major service~~  
12 ~~changes to certain officials and entities; and generally relating to ~~service reductions~~~~  
13 ~~or cancellations of major service changes for existing bus routes.~~

(a) Before announcing any service change that would constitute a major service change under the Federal Transit Administration's Title VI Requirements and Guidelines for Federal Transit Administration Recipients, the Department, in collaboration with the Administration, shall:

(1) Conduct a transit equity analysis in accordance with the federal Americans with Disabilities Act Amendments Act and the federal Rehabilitation Act of 1973 as amended to determine whether the change will create a disparate impact on persons with disabilities;

(2) Conduct a transit equity analysis in accordance with the Title VI Requirements and Guidelines for Federal Transit Administration Recipients to determine whether the change will create a disparate impact or a disproportionate burden;

(3) Perform a cost-benefit analysis, including an analysis of impacts on:

(i) Economic development;

(ii) Employment;

(iii) Education;

(iv) Health; and

(v) Environmental justice; and

(4) Consult with members and leaders of affected communities, including through community outreach to:

(i) Racial minority communities;

(ii) Low-income communities;

(iii) Disabled riders;

(iv) Riders with limited English proficiency;

(v) Transit-reliant riders; and

(vi) Senior riders.

1           **(b) (1) If a transit equity analysis reveals disparate impact or disproportionate**  
 2 **burden, the Administration shall:**

3                   **(i) Develop alternatives that would meet the goals of the proposed**  
 4 **service change; and**

5                   **(ii) Conduct a transit equity analysis on the alternatives.**

6           **(2) If a disparate impact can be avoided through use of one of the**  
 7 **alternatives analyzed, the Administration shall proceed with that alternative as the primary**  
 8 **proposed service change.**

9           **(3) If there is no alternative that would avoid a disparate impact or**  
 10 **disproportionate burden, the Administration:**

11                   **(i) May not implement the proposed service change unless a**  
 12 **substantial justification exists that necessitates the change; and**

13                   **(ii) Shall implement the alternative that causes the least disparate**  
 14 **impact or disproportionate burden.**

15           **(c) Before holding a public hearing on a proposed service change, the**  
 16 **Administration shall publish on the Administration's website **WITH A VISIBLE LINK****  
 17 ****IDENTIFYING THE PROPOSED SERVICE CHANGE ON THE PRIMARY PAGE**, for the routes**  
 18 ****[or lines], LINES, OR ANY CORRESPONDING PARATRANSIT SERVICE AREA** impacted by**  
 19 **the service change], an evaluation on the demographics of:**

20                   **(1) The riders of the routes or lines; and**

21                   **(2) The service area];**

11                           **(2) A SUMMARY OF ANY PUBLICLY AVAILABLE MINUTES, RECORDS, OR**  
 12 **DOCUMENTS RELATED TO THE PROPOSED SERVICE CHANGE; AND**

13                           **(3) A BRIEF STATEMENT EXPLAINING THE REASON FOR THE**  
 14 **PROPOSED SERVICE CHANGE.**

15            (d)    (1)    After completing the public hearings, the Administration shall:

16                            (i)    Publish the transit equity analysis and cost-benefit analysis on  
 17 the Administration's website; and

18                            (ii)   Compile a report on the impacts of the proposed service change.

19            (2)    The report shall include:

20                            (i)    The transit equity analysis;

21                            (ii)   The cost-benefit analysis;

22                            (iii)   A community outreach report;

23                            (iv)   Any alternatives analyzed; and

24                            (v)    If applicable, the final alternative selected.

25                            (3)    If a disparate impact or disproportionate burden exists in the final  
 26 alternative selected, the report shall include a substantial justification statement.

27            (4)    The report shall be:

1 (i) Made available to the public on the Administration’s website,  
2 with a visible link from the primary information page relating to the proposed service  
3 change; and

4 (ii) Distributed to:

5 1. The members of the Board of Public Works;

6 2. The Attorney General;

7 3. The Secretary of Transportation;

8 4. Any elected officials whose districts would be impacted by  
9 the proposed service change;

10 5. Any community leaders consulted during the community  
11 outreach process; and

12 6. In accordance with § 2-1257 of the State Government  
13 Article;

14 A. The President of the Senate;

15 B. The Speaker of the House;

16 C. The Senate Finance Committee; [and]

17 D. The House Environment and Transportation Committee;

18 AND

19 E. EACH MEMBER OF THE GENERAL ASSEMBLY WHOSE  
20 DISTRICT WOULD BE IMPACTED BY THE PROPOSED SERVICE CHANGE.

21 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
22 October 1, 2024.
