4 FOR the purpose of ~~authorizing~~ establishing a pilot program to authorize the use of noise
5 abatement monitoring systems in ~~Anne Arundel County~~, Montgomery County, and
6 Prince George's County to enforce certain motor vehicle noise requirements; and
7 generally relating to the use of noise abatement monitoring systems.

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
That the Laws of Maryland read as follows:

Article – Courts and Judicial Proceedings

4–401.

Except as provided in § 4–402 of this subtitle, and subject to the venue provisions of Title 6 of this article, the District Court has exclusive original civil jurisdiction in:

(13) A proceeding for a civil infraction under § 21–202.1, § 21–704.1, § 21–706.1, § 21–809, § 21–810, § 21–1134, **§ 22–612**, or § 24–111.3 of the Transportation Article or § 10–112 of the Criminal Law Article;

7–302.

(e) (1) (i) A citation issued pursuant to § 21–202.1, § 21–706.1, § 21–809, § 21–810, § 21–1134, **§ 22–612**, or § 24–111.3 of the Transportation Article shall provide that the person receiving the citation may elect to stand trial by notifying the issuing agency of the person’s intention to stand trial at least 5 days prior to the date of payment as set forth in the citation.

(ii) On receipt of the notice to stand trial, the agency shall forward to the District Court having venue a copy of the citation and a copy of the notice from the person who received the citation indicating the person’s intention to stand trial.

(iii) On receipt thereof, the District Court shall schedule the case for trial and notify the defendant of the trial date under procedures adopted by the Chief Judge of the District Court.

(2) (i) A citation issued as the result of a vehicle height monitoring system, a traffic control signal monitoring system, or a speed monitoring system, including a work zone speed control system, controlled by a political subdivision, a school bus monitoring camera, [or] a bus lane monitoring system, **OR A NOISE ABATEMENT MONITORING SYSTEM** shall provide that, in an uncontested case, the penalty shall be paid directly to that political subdivision.

(ii) A citation issued as the result of a traffic control signal monitoring system or a work zone speed control system controlled by a State agency, or as a result of a vehicle height monitoring system, a traffic control signal monitoring system, a speed monitoring system, a school bus monitoring camera, [or] a bus lane monitoring system, **OR A NOISE ABATEMENT MONITORING SYSTEM** in a case contested in District Court, shall provide that the penalty shall be paid directly to the District Court.

1 (3) Civil penalties resulting from citations issued using a vehicle height
2 monitoring system, traffic control signal monitoring system, speed monitoring system,
3 work zone speed control system, school bus monitoring camera, [or] bus lane monitoring
4 system, **OR A NOISE ABATEMENT MONITORING SYSTEM** that are collected by the District
5 Court shall be collected in accordance with subsection (a) of this section and distributed in
6 accordance with § 12–118 of the Transportation Article.

7 (4) (i) Except as provided in paragraph (5) of this subsection, from the
8 fines collected by a political subdivision as a result of violations enforced by speed
9 monitoring systems, school bus monitoring cameras, [or] bus lane monitoring systems, **OR**
10 **NOISE ABATEMENT MONITORING SYSTEMS**, a political subdivision:

11 1. May recover the costs of implementing and administering
12 the speed monitoring systems, school bus monitoring cameras, [or] bus lane monitoring
13 systems, **OR NOISE ABATEMENT MONITORING SYSTEMS**; and

14 2. Subject to subparagraphs (ii), (iii), and (iv) of this
15 paragraph, may spend any remaining balance solely for public safety purposes, including
16 pedestrian safety programs.

18 (a) A recorded image of a motor vehicle produced by a traffic control signal
19 monitoring system in accordance with § 21–202.1 of the Transportation Article is
20 admissible in a proceeding concerning a civil citation issued under that section for a
21 violation of § 21–202(h) of the Transportation Article without authentication.

22 (b) A recorded image of a motor vehicle produced by a speed monitoring system
23 in accordance with § 21–809 or § 21–810 of the Transportation Article is admissible in a
24 proceeding concerning a civil citation issued under that section for a violation of Title 21,
25 Subtitle 8 of the Transportation Article without authentication.

26 (c) A recorded image of a motor vehicle produced by a school bus monitoring
27 camera in accordance with § 21–706.1 of the Transportation Article is admissible in a
28 proceeding concerning a civil citation issued under that section for a violation of § 21–706
29 of the Transportation Article without authentication.

30 (d) A recorded image of a motor vehicle produced by a vehicle height monitoring
31 system in accordance with § 24–111.3 of the Transportation Article is admissible in a
32 proceeding concerning a civil citation issued under that section for a violation of a State or
33 local law restricting the presence of certain vehicles during certain times without
34 authentication.

35 (e) A recorded image of a motor vehicle produced by a bus lane monitoring system
36 in accordance with § 21–1134 of the Transportation Article is admissible in a proceeding

1 concerning a civil citation issued under that section for a violation of § 21–1133 of the
2 Transportation Article without authentication.

3 (f) **A RECORDED IMAGE OF A MOTOR VEHICLE AND ANY RELEVANT**
4 **RECORDED AUDIO PRODUCED BY A NOISE ABATEMENT MONITORING SYSTEM IN**
5 **CONJUNCTION WITH A NOISE MEASURING DEVICE IN ACCORDANCE WITH § 22–612**
6 **OF THE TRANSPORTATION ARTICLE IS ADMISSIBLE IN A PROCEEDING CONCERNING**
7 **A CIVIL CITATION ISSUED UNDER THAT SECTION FOR A VIOLATION OF § 22–602 OF**
8 **THE TRANSPORTATION ARTICLE WITHOUT AUTHENTICATION.**

9 (g) In any other judicial proceeding, a recorded image produced by a vehicle
10 height monitoring system, traffic control signal monitoring system, speed monitoring
11 system, work zone speed control system, school bus monitoring camera, or bus lane
12 monitoring system **OR A RECORDED IMAGE AND ANY RELEVANT RECORDED AUDIO**
13 **PRODUCED BY A NOISE ABATEMENT MONITORING SYSTEM IN CONJUNCTION WITH A**
14 **NOISE MEASURING DEVICE** is admissible as otherwise provided by law.

17 (a) A person may not drive on a highway in this State any motor vehicle or
18 combination of vehicles of a type required to be registered under Title 13 of this article, in
19 a manner that, at any time, at any speed, or under any condition of grade, load,
20 acceleration, or deceleration, exceeds the maximum sound level limits established under §
21 22–601 of this subtitle for the operation of that type of motor vehicle or combination of
22 vehicles.

23 (b) An owner or lessee of a motor vehicle may not permit to be driven on a highway
24 in this State any motor vehicle or combination of vehicles of a type required to be registered
25 under Title 13 of this article, in a manner that, at any time, at any speed, or under any
26 condition of grade, load, acceleration, or deceleration, exceeds the maximum sound level
27 limits established under § 22–601 of this subtitle for the operation of that type of motor
28 vehicle or combination of vehicles.

20 (I) USES AUTOMATED EQUIPMENT THAT ACTIVATES WHEN THE
21 SOUND LEVEL EXCEEDS THE MAXIMUM SOUND LEVEL LIMITS ESTABLISHED UNDER
22 § 22-601 OF THIS SUBTITLE BY AT LEAST 5 DECIBELS;

23 (II) RECORDS AUDIO WHEN ACTIVATED;

24 (III) RECORDS DECIBEL LEVELS WHEN ACTIVATED; AND

25 (IV) ALLOWS A NOISE ABATEMENT MONITORING SYSTEM
26 OPERATOR TO MANUALLY REVIEW RECORDED AUDIO TO ENSURE A VIOLATION HAS
27 OCCURRED.

- 8 3. AN ELECTRONIC IMAGE;

- 12 1. THE REAR OF A MOTOR VEHICLE;
- 13 2. THE DECIBEL LEVEL RECORDED FOR THE MOTOR

16 **PROVIDES SUFFICIENT EVIDENCE THAT THE PERSON HAS MADE ANY ALTERATIONS**
17 **TO THE MOTOR VEHICLE NECESSARY TO AVOID FUTURE VIOLATIONS.**

10 **(III) THE CERTIFICATE OF TRAINING SHALL BE ADMITTED AS**
11 **EVIDENCE IN ANY COURT PROCEEDING FOR A VIOLATION.**

12 **(3) A NOISE ABATEMENT MONITORING SYSTEM OPERATOR SHALL**
13 **FILL OUT AND SIGN A DAILY SET-UP LOG FOR A NOISE ABATEMENT MONITORING**
14 **SYSTEM THAT:**

15 **(I) STATES THAT THE NOISE ABATEMENT MONITORING SYSTEM**
16 **OPERATOR SUCCESSFULLY PERFORMED OR REVIEWED AND EVALUATED THE**
17 **MANUFACTURER-SPECIFIED DAILY SELF-TEST OF THE NOISE ABATEMENT**
18 **MONITORING SYSTEM BEFORE PRODUCING A RECORDED IMAGE;**

19 **(II) STATES THE DATE AND TIME WHEN, AND THE LOCATION**
20 **WHERE, THE NOISE ABATEMENT MONITORING SYSTEM WAS SET UP EACH DAY;**

21 **(III) SHALL BE KEPT ON FILE; AND**

22 **(IV) SHALL BE ADMITTED AS EVIDENCE IN ANY COURT**
23 **PROCEEDING FOR A VIOLATION.**

24 **(4) (I) A NOISE ABATEMENT MONITORING SYSTEM SHALL**
25 **UNDERGO AN ANNUAL CALIBRATION CHECK PERFORMED BY AN INDEPENDENT**
26 **CALIBRATION LABORATORY THAT IS:**

27 **1. SELECTED BY THE ~~LOCAL JURISDICTION~~ COUNTY;**
28 **AND**

29 **2. UNAFFILIATED WITH THE MANUFACTURER OF THE**
30 **NOISE ABATEMENT MONITORING SYSTEM.**

1 **(II) THE INDEPENDENT CALIBRATION LABORATORY SHALL**
 2 **ISSUE A SIGNED CERTIFICATE OF CALIBRATION AFTER THE ANNUAL CALIBRATION**
 3 **CHECK THAT SHALL BE:**

4 **1. KEPT ON FILE; AND**

5 **2. ADMITTED AS EVIDENCE IN ANY COURT PROCEEDING**
 6 **FOR A VIOLATION.**

7 **(5) A ~~LOCAL JURISDICTION~~ COUNTY THAT ESTABLISHES A NOISE**
 8 **ABATEMENT MONITORING SYSTEM PROGRAM SHALL BEAR THE COST OF**
 9 **IMPLEMENTING THE PROGRAM.**

10 **(D) (1) UNLESS THE DRIVER OF THE MOTOR VEHICLE RECEIVED A**
 11 **CITATION FROM A POLICE OFFICER AT THE TIME OF THE VIOLATION, THE OWNER OF**
 12 **A MOTOR VEHICLE IS SUBJECT TO A CIVIL PENALTY IF THE MOTOR VEHICLE IS**
 13 **RECORDED BY A NOISE ABATEMENT MONITORING SYSTEM WHILE BEING OPERATED**
 14 **DURING THE COMMISSION OF A VIOLATION.**

15 **(2) (I) A PERSON LIABLE FOR A VIOLATION ENFORCED BY A NOISE**

1 (ii) the revenue collected on a monthly basis as a result of violations
2 recorded by noise abatement monitoring systems;

3 (3) appropriate locations for the deployment of noise abatement monitoring
4 systems;

5 (4) the performance and reliability of noise abatement monitoring systems
6 used by the county; and

7 (5) the effectiveness of noise abatement monitoring systems in reducing
8 noise produced by motor vehicles in the county and in areas where the systems were
9 implemented and used.

10 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect
11 ~~October~~ July 1, 2024. It shall remain effective for a period of ~~4~~ 2 years and, at the end of
12 ~~September~~ June 30, ~~2028~~ 2026, this Act, with no further action required by the General
13 Assembly, shall be abrogated and of no further force and effect.
