A BILL ENTITLED

1 AN ACT concerning

2 **Department of Natural Resources – Pay-For-Success Contracts – Procurement**
3 **Exemption**

4 FOR the purpose of exempting pay-for-success contracts negotiated or entered into by the
5 Department of Natural Resources from certain provisions of the General
6 Procurement Law; and generally relating to pay-for-success contracts.

17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
18 That the Laws of Maryland read as follows:

19 **Article – State Finance and Procurement**

8 (a) (1) In this section the following words have the meanings indicated.

9 (3) “Environmental outcome” means a commodity that is modeled or
10 directly measured as a single, quantifiable, and certified unit of improvement to the
11 environment, including a nutrient or carbon benefit.

12 (b) The General Assembly finds and declares that:

13 (1) pay-for-success contracting shifts the risk of performance to the
14 contractor because government payment is made only on achievement of outcomes;

15 (2) social and environmental impact investment is growing dramatically,
16 and investors are seeking ways to finance and execute pay-for-success contracts in the
17 State to expand the success of Chesapeake Bay restoration efforts and achieve other public
18 outcomes; and

19 (3) it is in the best interest of the State to include pay-for-success
20 contracting as a procurement option, particularly for units responsible for land
21 conservation and environmental protection, enhancement, and restoration.

22 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
23 October 1, 2024.
